a. Exhibitor

The contract between the exhibitor and the organizer comes into force on confirmation of the booking by the organizer. A cancellation after receipt of confirmation is governed by item 7 of the “General Conditions for Participation in Fairs and Exhibitions” accordingly for the costs of the complete package booked.

b. Sponsor

The contract between the sponsor and the organizer comes into force on confirmation of the booking by the organizer. If the sponsor cancels his package after receipt of the booking confirmation, he is obliged to pay a cancellation fee as follows:

- up to and including 28.08.2025 25% of the agreed package price
- from 29.08.2025 100% of the agreed package price

6. Payment conditions

a. Exhibitor

The exhibitor will be charged the full stand rental fee with the stand confirmation.

b. Sponsor

The sponsor will be invoiced for the entire sponsoring package with the booking confirmation.

c. Further conditions

The invoice is payable in full. All payments are to be made in EURO without charges, quoting invoice number. An entitlement to occupy the allocated stand space or receive the services of the sponsoring package exists only after payment of invoices in full. The exhibitor or sponsor is to provide proof of payment.
