

GUN SECURITY AND STAND SECURITY MANAGER

Please read the following information on the prevention of theft carefully and then complete the form for stand security manager.

- ▶ Products requiring permits must be secured against theft and unauthorized access at all times of the day and night, expressly also during the trade fair.
- ▶ The presentation must be designed in such a way that they can be viewed by stand personnel at all times.
- ▶ We recommend that valuable goods and especially products requiring permits under German firearms law including prohibited arms and articles get locked away at night. Alternatively you can commission a stand guard in order to ensure the safety of your products at night.

Mechanical safety:

- ► Firearms must be secured mechanically with steel cables, chains or other suitable fixing devices.
- As a rule, this type of safety device must also be used in display cases or similar (only if display cases have swing bolt locks or an acoustic safety device can an additional safety device be dispensed with).
- ▶ The steel cables themselves must be connected to the respective firearms. No plastic intermediate piece (such as a cable tie) may be used.
- ▶ Ammunition must be kept in locked containers (showcases), unless "dummy ammunition" (non-functioning ammunition) is displayed. Combination locks must be secured with individual number combinations. Do not use simple number combinations such as 0000 or 1234.
- ▶ The permanent presence of stand personnel is no substitute for a mechanical safety device.

Notes:

- ▶ All weapons requiring licences must be appropriately secured by 8:00 p.m. on Wednesday, 25.02.2026.
- ▶ In the event of inadequate security, the organizer reserves the right to take security measures at the exhibitor's expense.
- ▶ Products requiring licences should only be delivered to the stand from 2:00 p.m. on Wednesday, 25.02.2026. These products should be removed by 8:00 p.m. on Sunday, 01.03.2026.

STAND SECURITY MANAGER

Every exhibitor who presents products requiring a license on the stand must appoint a responsible person and a deputy before the trade fair.

The details of the person responsible for the stand and the deputy will be used exclusively for the purpose of contacting the event management and the local authorities.

Naming the stand managers is mandatory for participation in IWA OutdoorClassics.

- ▶ The stand manager is responsible for complying with the above-mentioned regulations on gun safety.
- ▶ The stand manager must be present at the stand at all times during set-up, the duration of the trade fair and dismantling if the weapons are not yet or no longer properly secured.
- ▶ In order to be able to contact the stand manager for queries, mobile phone numbers must be entered in the form.
- ▶ The stand security manager must be available by telephone for queries at the following times:
 - During the whole duration of the assembly, especially on the last assembly day (25.2.2026) until 10:00 p.m.
 - During the whole run-time of the exhibition, especially on the first exhibition day (26.2.2026) starting at 7:30 a.m.
- ▶ The deputy stand manager may only take on the above tasks at short notice.
- ▶ The stand manager is responsible for securing the weapons of the direct exhibitor and co-exhibitor.
