### **EXCEPTIONS TO RULES AND REGULATIONS**

Exception to Saddlehorn Pipeline Company, LLC’s **[W]** ~~currently effective F.E.R.C. No. 1-3-0, supplements thereto and reissues thereof~~, Item 60: Measurement and Tender Deductions, paragraphs 4 and 5 are deleted in their entirety and replaced with the following:

A deduction of two-tenths (2/10) of one percent by volume will be assessed on each shipment received by Carrier for delivery to Platteville, CO, as referenced under this tariff in Item Nos. 120 and 130.

A deduction of three-tenths (3/10) of one percent by volume will be assessed on each shipment received by Carrier for delivery to Cushing, OK, as referenced under this tariff in Item Nos. 100 and 110.

**[W]** Exception to Saddlehorn Pipeline Company, LLC’s ~~currently effective F.E.R.C. No. 1-3-0, supplements thereto and reissues hereof~~, Item 30: Storage is deleted in its entirety and replaced with the following:

Only storage necessarily incident to transportation and only such storage will be provided by Carrier. Upon delivery of Crude Petroleum into Carrier’s working tankage, title to such Crude Petroleum in Carrier’s working tankage shall remain with Shipper and not with Carrier.
