**Note 1:** Proportional origins are local origins only, excluding the Pine Bend, MN joint origin contained in Item No. 205 of Carrier's currently effective F.E.R.C. No. 160.

**Note 2:** Rates and routes in Item No. 100 are only for proportional movements by which Petroleum Product is delivered to Carrier's Kansas City (Fairfax), KS; Kansas City (Olathe), KS; Topeka, KS; Tulsa, OK; and Wichita, KS facilities and subsequently loaded out across Carrier's truck rack for a further movement via truck and delivered to Oklahoma City, OK and/or Fort Smith, AR markets. This movement and rate will only apply if the barrels qualify based on bill of lading (BOL) delivery points.

**Note 3:** Oklahoma City, OK and Fort Smith, AR Markets are defined in this tariff to include BOL delivery points, in which the Inventory Owner who takes credit for delivery must supply verification of delivery in the following listed counties.

- a. The Oklahoma City, OK Market includes Canadian, Cleveland, Grady, Kingfisher, Lincoln, Logan, McClain, Oklahoma, and Pottawatomie Counties in Oklahoma.
- b. The Fort Smith, AR Market includes Crawford, Franklin, Logan, Polk, Scott, Sebastian, Washington, and Yell Counties in Arkansas; Haskell, LeFlore, and Sequoyah Counties in Oklahoma.

The application of the Proportional Rate will occur when Petroleum Product is delivered out of Carrier's terminals, by Inventory Owner who takes credit of delivery into the above counties, supported by BOL, showing the county and state of each delivery point. Inventory Owner must supply evidence to Carrier verifying delivery to a qualifying delivery point within forty-five (45) days following the last day of the month in which the Petroleum Product was delivered.

**Note 4:** The proportional movements and rates will only be available through April 30, 2026 unless extended via a subsequent filing of this tariff.
