Item 30-Volume Correction and Tender Deductions, Section B. A ~~**[W]**~~ ~~₹~~ Tender deduction of three-tenths (3/10th) of one percent (1%) by volume will be made on the quantity of Petroleum Products accepted for transportation.

Note 2: The product movement route defined in this Item 200, is a reversal of the normal product flow of the MPL’s south pipeline system and will only be made upon request by ~~**[W]**~~ ~~₹~~ Shipper and upon MPL’s determination that such movement can operationally and efficiently be made to accommodate ~~₹~~ Shipper’s request. Additionally, only Conventional Gasoline and Ultra Low Sulfur Diesel Fuel shall be shipped under Item 200.

[W] The rates herein apply from KPL's Pine Bend, MN (Flint Hills Resources, L.P. Refinery), Dakota County, MN to the interconnection at Magellan Pipeline Company ~~Line~~, L.P. Rosemount, MN thence to destination.
