Except as otherwise expressly provided herein, the rates published in this tariff and the services hereunder are governed by the Rules and Regulations published in Cenex Pipeline, LLC's F.E.R.C. No. **[W] 16.9.0** ~~16.8.0~~, supplements thereto and reissues thereof with respect to that portion of the transportation services provided by Cenex Pipeline, LLC and Magellan Pipeline Company, L.P.'s F.E.R.C. No. **[W] 157.34.0** ~~157.33.0~~, supplements thereto and reissues thereof, with respect to that portion of the transportation services provided by Magellan Pipeline Company, L.P. (respectively, the "Cenex Rules" and the "Magellan Rules"). Any conflicts between the terms of the Magellan Rules and the Cenex Rules with respect to the entirety of the joint pipeline transportation governed by this Tariff shall be resolved in favor of the governed by the applicable provision of the Magellan Rules.

The rates named in this Tariff are expressed in cents a barrel of 42 U.S. Gallons and are subject to change as provided by law.
