OkTex Pipeline Company, L.L.C.

Issued: April 30, 2025

On January 31, 2025, OkTex Pipeline Company, L.L.C. filed tariff records¹ to comply with Order No. 587-AA, which amended the Commission's regulations to incorporate by reference, with certain enumerated exceptions, Version 4.0 of Standards for Business Practices of Interstate Natural Gas Pipelines adopted by the Wholesale Gas Quadrant of the North American Energy Standards Board.² Pursuant to authority delegated to the Director, Division of Pipeline Regulation, under 18 C.F.R. § 375.307, the tariff records are accepted, effective August 1, 2025, as requested.

The filing was publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission's regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.

This action shall not be construed as a waiver of the requirements of section 7 of the Natural Gas Act, as amended; nor shall it be construed as constituting approval of the referenced filing or of any rate, charge, classification, or any rule, regulation, or practice affecting such rate or service contained in the applicant's tariff; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against the applicant.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.

Pursuant to Section 4 of the Natural Gas Act and Part 154 of the Federal Energy Regulatory Commission's ("Commission") regulations and the Commission's Order No. 587-AA¹ issued November 22, 2024, in Docket No. RM96-1-043, OkTex Pipeline Company, L.L.C. ("OkTex") respectfully submits for filing and acceptance the tariff records listed below for inclusion in its FERC Gas Tariff, Volume No. 1 ("Tariff"). The proposed tariff records are submitted to become effective August 1, 2025.

Part 8.30, Procedures to Inform Shippers, v. 5.0.0
Part 8.39, NAESB WGQ Standards, v. 7.0.0

Statement of Nature, Reasons, and Basis for the Proposed Changes

On November 22, 2024, in Docket No. RM96-1-043, the Commission issued Order No. 587-AA (the "Order") amending Section 284.12 of its open access regulations, 18 C.F.R. § 284.12, governing standards for conducting business practices and electronic communications with interstate natural gas pipelines. Specifically, the Commission adopted, with certain enumerated exceptions, the latest version ("Version 4.0") of the consensus industry standards promulgated by the Wholesale Gas Quadrant ("WGQ") of the North American Energy Standards Board ("NAESB") by incorporating these standards by reference into its regulations.

The revised tariff records included herein reflect the Version 4.0 standards adopted by the Order and incorporated by reference into the Commission's regulations. Additionally, General Terms & Conditions Section 39 of the Tariff reflects the format of the tariff provision set forth in the Sample Tariff Record issued by the Commission on November 25, 2024.²

Adoption of Standards

Consistent with the requirements in the Order, OkTex submits herein revisions to Sections 30 and 39 of the General Terms and Conditions ("GT&C") of its Tariff to reflect the latest version of the NAESB standards adopted by the Commission.

OkTex proposes to consolidate the standards from Books 4 and 10 into new Book 12. OkTex also proposes to adopt by reference the modifications to existing referenced standards required by NAESB Version 4.0. Section 39 of the GT&C has been revised to reference NAESB Version 4.0 and update NAESB's limited copyright waiver language. OkTex also proposes administrative edits in both sections.

Proposed Effective Date

Pursuant to section 154.207 of the Commission's regulations and the Order,³ OkTex respectfully requests that the proposed tariff records be approved effective August 1, 2025. In accordance with section 154.7(a)(9) of the Commission's regulations, OkTex hereby files a motion to place the proposed tariff records into effect at the end of any suspension period if one is so ordered by the Commission in this proceeding.

Waivers and Extensions of Time

In accordance with the Commission's policy on waiver requests from the Order,⁴ OkTex does not request any waivers of Version 4.0 of NAESB's standards. OkTex does not request an extension of time beyond the Commission's deadline for implementation of NAESB Version 4.0 Standards.

Pursuant to section 154.7(a)(7) of the Commission's regulations, OkTex has not identified any additional waivers of the Commission's regulations needed to permit its filing to become effective as proposed; however, OkTex respectfully requests that, should the Commission determine that any such waivers are required, the Commission grant such waivers as are necessary in order that the revised tariff records may be made effective as proposed.

Clean Tariff Records

30. PROCEDURES TO INFORM SHIPPERS - INFORMATIONAL POSTINGS AND CUSTOMER ACTIVITIES WEB SITES

30.1 Inquiries related to the capacity at receipt points, on the mainlines, and/or at delivery points and whether such capacity is available directly from Transporter or by capacity release on Transporter's system should be directed to Transporter's Informational Postings Web site.

30.2 In accordance with NAESB WGQ Standard Nos. 4.3.22, 4.3.23, 4.3.24, 4.3.25, 4.3.26, 4.3.27, and 4.3.28, Transporter has established an Informational Postings Web site for use by any party, including Shippers and potential shippers. The Informational Postings Web site is available on a nondiscriminatory basis to any party that has compatible equipment for electronic transmission of data, provided that such party agrees to comply with the procedures for access to and for use of the Informational Postings Web site.

30.3 The Informational Postings Web site will, to the extent necessary, permit users to electronically download a file(s) from the Informational Postings Web site and split extremely large files into smaller files prior to such download. Transporter will maintain and retain daily back-up records of the information displayed on the Informational Postings Web site for three (3) years and permit users to review those records, which will be archived and reasonably accessible. Transporter will periodically purge transactions from current Informational Postings Web site files when transactions have been completed. Information on the most recent entries will appear ahead of older information.

30.4 A user has the option to utilize the Informational Postings Web site for the purposes of (a) requesting service and tracking service agreements; (b) exercising its rights as an existing Shipper of Transporter pursuant to Section 32 of the General Terms and Conditions or submitting a bid as a potential shipper of Transporter under such article; or (c) participating in Transporter's capacity release program pursuant to Section 33 of the General Terms and Conditions.

30.5 Transporter shall inform, on a timely basis via the Informational Postings Web site, all interested persons about the availability of firm and interruptible capacity (a) at receipt points; (b) on each pipeline segment, and (c) at delivery points, and whether such capacity is available directly from the Transporter or indirectly from Transporter's capacity release program. Transporter shall maintain both in written form and on its Informational Postings Web site a master receipt point list containing the following information for each pipeline segment. Such information shall be updated promptly when additional pipeline segments or receipt points are added to the system.

- (a) Name of Receipt Point;
- (b) Meter number of receipt point;
- (c) Location (legal description) of receipt point;
- (d) Operator name and phone number to the extent available;

- (e) Availability of electronic gas measurement;
- (f) Receipt point design capacity;
- (g) Any firm capacity already assigned at the point;

30.6 Transporter shall comply with NAESB WGQ Quadrant Electronic Delivery Mechanism related standards: 4.3.1-3, 4.3.16-18, 4.3.20, 4.3.22-28, 4.3.30-36, 4.3.38, 4.3.40-50, 4.3.52-55, 4.3.57, 4.3.58, 4.3.66-69, 4.3.72, 4.3.75, 4.3.78-82, 4.3.85-87, 4.3.89-105, and NAESB WGQ Cybersecurity Related Standards 12.3.1, 12.3.2, and 12.3.12-25.

30.7 Trading partner agreements and minimum sites shall be in accordance with NAESB WGQ Standard No. 12.3.9. The roles of senders and receivers are defined as specified in NAESB WGQ Standard No. 12.3.12. Security between Transporter and trading partners will adhere to NAESB WGQ Standard No. 12.3.13. The Form of Electronic Data Interchange (EDI) Trading Partner Agreement is located on the Customer Activities Web site at www.oneok.com/okt.

30.8 Transporter, on the effective date of and pursuant to Section 33 of the General Terms and Conditions, will post on the Informational Postings Web site for a reasonable time the price, terms and conditions, and names of the parties to all capacity release and assignment agreements existing on that date. All firm capacity holders who have executed such agreements prior to that date must provide such information to the Transporter for posting on the Informational Postings Web site. Such posting is to make those agreements public and not to prompt potential shippers to submit a bid for such capacity.

30.9 Transporter will provide access to an on-line, read-only copy of its currently effective FERC Gas Tariff, including the General Terms and Conditions via the Informational Postings Web site.

30.10 Any provisions of this FERC Gas Tariff requiring that these matters be written or in writing are satisfied by either Shipper or Transporter utilizing electronic transmission through the Informational Postings Web site in accordance with the procedures for utilization of the Informational Postings Web site when subsequently verified by a timely signed writing. All other provisions requiring items or information to be written or in writing remain unchanged.

30.11 In order to access Transporter's Customer Activities Web site, Shipper must contact Transporter. If requested, Transporter will provide the address, telephone number, and user fees of Transporter's Customer Activities Web site service provider.

30.12 Transporter is the exclusive proprietor of the Customer Activities Web site and of all the copyrights and proprietary interests therein, except insofar as any third party possesses a copyright or proprietary interest in such materials. Shipper will not by virtue of this Article or the executed Customer Activities Web site Agreement acquire any proprietary interests in the Customer Activities Web site or its files. Although Transporter is not the

proprietor of certain data and information contained in the files of the Customer Activities Web site, Shipper will use the Customer Activities Web site for research purposes only and will not publish, broadcast, sell, or use any material received from the Customer Activities Web site in any manner of fashion that may infringe any copyrights or proprietary interests Transporter or any third party may have in the Customer Activities Web site and materials included therein.

30.13 Shipper assumes sole responsibility for all use of the Customer Activities and/or Informational Postings Web sites and hereby indemnifies and holds Transporter harmless against any liability or claim of any person that is attributed to improper use of the Customer Activities/Informational Postings Web sites by Shipper. In no event will Transporter be liable to Shipper for consequential, exemplary, or special damages resulting, in whole or in part, from Shipper's use of the Customer Activities/Informational Postings Web sites.

30.14 Transporter's employees are not authorized to assist Shipper in framing a search request. If, notwithstanding the foregoing, a Shipper requests and/or receives assistance from Transporter employees in framing a search request, such assistance will be at Shipper's risk and Transporter will not have any responsibility or liability arising therefrom. For the purposes of this Article, "framing a search request" shall mean the process by which a Shipper identifies the research problem, selects the words, phrases, or numbers to be searched upon, and determines the relationship to each other of such words, phrases, and numbers and the order in which they are to be submitted.

30.15 Transporter warrants that, without the express consent of Shipper or as provided for in Section 32 or 33 of the General Terms and Conditions, no Transporter's employee or agent will disclose to any third party any information regarding research performed through the use of the Informational Postings Web site by Shipper.

30. PROCEDURES TO INFORM SHIPPERS - INFORMATIONAL POSTINGS AND CUSTOMER ACTIVITIES WEB SITES

30.1 Inquiries related to the capacity at receipt points, on the mainlines, and/or at delivery points and whether such capacity is available directly from Transporter or by capacity release on Transporter's system should be directed to Transporter's Informational Postings Web site.

30.2 In accordance with NAESB WGQ Standard Nos. 4.3.22, 4.3.23, 4.3.24, 4.3.25, 4.3.26, 4.3.27, and 4.3.28, Transporter has established an Informational Postings Web site for use by any party, including Shippers and potential shippers. The Informational Postings Web site is available on a nondiscriminatory basis to any party that has compatible equipment for electronic transmission of data, provided that such party agrees to comply with the procedures for access to and for use of the Informational Postings Web site.

30.3 The Informational Postings Web site will, to the extent necessary, permit users to electronically download a file(s) from the Informational Postings Web site and split extremely large files into smaller files prior to such download. Transporter will maintain and retain daily back-up records of the information displayed on the Informational Postings Web site for three (3) years and permit users to review those records, which will be archived and reasonably accessible. Transporter will periodically purge transactions from current Informational Postings Web site files when transactions have been completed. Information on the most recent entries will appear ahead of older information.

30.4 A user has the option to utilize the Informational Postings Web site for the purposes of (a) requesting service and tracking service agreements; (b) exercising its rights as an existing Shipper of Transporter pursuant to Section 32 of the General Terms and Conditions or submitting a bid as a potential shipper of Transporter under such article; or (c) participating in Transporter's capacity release program pursuant to Section 33 of the General Terms and Conditions.

30.5 Transporter shall inform, on a timely basis via the Informational Postings Web site, all interested persons about the availability of firm and interruptible capacity (a) at receipt points; (b) on each pipeline segment, and (c) at delivery points, and whether such capacity is available directly from the Transporter or indirectly from Transporter's capacity release program. Transporter shall maintain both in written form and on its Informational Postings Web site a master receipt point list containing the following information for each pipeline segment. Such information shall be updated promptly when additional pipeline segments or receipt points are added to the system.

- (a) Name of Receipt Point;
- (b) Meter number of receipt point;
- (c) Location (legal description) of receipt point;
- (d) Operator name and phone number to the extent available;

- (e) Availability of electronic gas measurement;
- (f) Receipt point design capacity;
- (g) Any firm capacity already assigned at the point;

30.6 Transporter shall comply with NAESB WGQ Quadrant Electronic Delivery Mechanism related standards: 4.3.1-3, 4.3.16-18, 4.3.20, 4.3.22-28, 4.3.30-36, 4.3.38, 4.3.40-50, 4.3.52-55, 4.3.57, 4.3.58, ~~4.3.60-62~~, 4.3.66-69, 4.3.72, 4.3.75, 4.3.78-~~87~~~~82~~, ~~4.3.85-87~~, ~~4.3.89-105~~, ~~10.3.1~~, ~~10.3.3-12~~, and ~~10.3.14-27~~ and NAESB WGQ Cybersecurity Related Standards 12.3.1, 12.3.2, and 12.3.12-25.

30.7 Trading partner agreements and minimum sites shall be in accordance with NAESB WGQ Standard No. ~~10.3.10~~12.3.9. The roles of senders and receivers are defined as specified in NAESB WGQ Standard No. 12.3.12~~10.3.14~~. Security between Transporter and trading partners will adhere to NAESB WGQ Standard No. ~~10.3.15~~12.3.13. The Form of Electronic Data Interchange (EDI) Trading Partner Agreement is located on the Customer Activities Web site at www.oneok.com/okt.

30.8 Transporter, on the effective date of and pursuant to Section 33 of the General Terms and Conditions, will post on the Informational Postings Web site for a reasonable time the price, terms and conditions, and names of the parties to all capacity release and assignment agreements existing on that date. All firm capacity holders who have executed such agreements prior to that date must provide such information to the Transporter for posting on the Informational Postings Web site. Such posting is to make those agreements public and not to prompt potential shippers to submit a bid for such capacity.

30.9 Transporter will provide access to an on-line, read-only copy of its currently effective FERC Gas Tariff, including the General Terms and Conditions via the Informational Postings Web site.

30.10 Any provisions of this FERC Gas Tariff requiring that these matters be written or in writing are satisfied by either Shipper or Transporter utilizing electronic transmission through the Informational Postings Web site in accordance with the procedures for utilization of the Informational Postings Web site when subsequently verified by a timely signed writing. All other provisions requiring items or information to be written or in writing remain unchanged.

30.11 In order to access Transporter's Customer Activities Web site, Shipper must contact Transporter. If requested, Transporter will provide the address, telephone number, and user fees of Transporter's Customer Activities Web site service provider.

30.12 Transporter is the exclusive proprietor of the Customer Activities Web site and of all the copyrights and proprietary interests therein, except insofar as any third party possesses a copyright or proprietary interest in such materials. Shipper will not by virtue of this Article or the executed Customer Activities Web site Agreement acquire any proprietary

interests in the Customer Activities Web site or its files. Although Transporter is not the proprietor of certain data and information contained in the files of the Customer Activities Web site, Shipper will use the Customer Activities Web site for research purposes only and will not publish, broadcast, sell, or use any material received from the Customer Activities Web site in any manner of fashion that may infringe any copyrights or proprietary interests Transporter or any third party may have in the Customer Activities Web site and materials included therein.

30.13 Shipper assumes sole responsibility for all use of the Customer Activities and/or Informational Postings Web sites and hereby indemnifies and holds Transporter harmless against ~~and any~~ liability or claim of any person that is attributed to improper use of the Customer Activities/Informational Postings Web sites by Shipper. In no event will Transporter be liable to Shipper for consequential, exemplary, or special damages resulting, in whole or in part, from Shipper's use of the Customer Activities/Informational Postings Web sites.

30.14 Transporter's employees are not authorized to assist Shipper in framing a search request. If, notwithstanding the foregoing, a Shipper requests and/or receives assistance from Transporter employees in framing a search request, such assistance will be at Shipper's risk and Transporter will not have any responsibility or liability arising therefrom. For the purposes of this Article, "framing a search request" shall mean the process by which a Shipper identifies the research problem, selects the words, phrases, or numbers to be searched upon, and determines the relationship to each other of such words, phrases, and numbers and the order in which they are to be submitted.

30.15 Transporter warrants that, without the express consent of Shipper or as provided for in Section 32 or 33 of the General Terms and Conditions, no Transporter's employee or agent will disclose to any third party any information regarding research performed through the use of the Informational Postings Web site by Shipper.
