Manager – Area Operations (DOT)	Oversee gathering, transmission, storage, and processing activities for a geographic area including pipeline construction and maintenance, regulatory compliance, and budgets.
Manager - Gas Control	Responsible for directing the flow of natural gas and/or natural gas liquids through the pipeline systems.
Manager – Marketing Services	This position is responsible for identifying, developing, and implementing expansion capital projects within a geographic region, as well as identifying and pursuing potential acquisitions. In addition, responsibilities include analysis and monitoring of the commercial performance of the assets. This position regularly interacts with customers to understand their business needs, identify potential growth opportunities, and negotiate commercial agreements.
Manager – Transportation Services and Contract Administration	Manages and directs daily scheduling activities for facilities and pipelines. Manages administration of contracts and agreements related to transportation and storage services, gas sales and purchases, gathering, exchanges, throughput commitments, compression changes, and/or service contracts for operating, maintenance, and construction projects.
Pipeline Controller	Monitors, adjusts, and/or controls flow of gas through the pipeline system in a safe, reliable, compliant, and efficient manner. This includes distribution, transmission, storage and processing systems.
Pipeline Controller - Senior	Coordinates daily operations of the pipeline control group with SCADA and Field Operations. Performs senior level activities related to monitoring, adjusting, and/or controlling flow of gas or natural gas liquids through the pipeline system in a safe, reliable,



	compliant, and efficient manner. This includes transmission, gathering, storage and processing systems.
Pipeline Controller Trainee	Performs duties related to monitoring and controlling flow of gas or natural gas liquids through the pipeline system in a safe, reliable, compliant, and efficient manner. This includes transmission, gathering, storage and processing systems.
Pipeline System Planner I	Perform intermediate level duties related to pipeline system planning and analysis, gathering system operation, construction estimates; and/or design and coordination of pipeline construction projects.
Pipeline System Planner II	Perform advanced level duties related to pipeline system planning and analysis, gathering system operation, construction estimates; and/or design and coordination of pipeline construction projects.
Pipeline System Planner III	Provide specialized duties related to pipeline system planning, analysis, optimization, gathering system operation, construction estimates; and/or design and coordination of pipeline construction projects.
Real Estate Contract Analyst Coordinator	Collaborates, prepares, analyzes, negotiates, interprets, and communicates information from non-standard complex legal documents pertaining to leases, underground gas storage agreements, gas supply/service contracts, natural gas liquids and natural gas purchases, sales contracts, gathering and processing contracts, licenses, fee properties, rights-of-way, and easements.
Scheduler I	Performs advanced level of work related to nomination, confirmation, and scheduling activities for natural gas pipelines, local distribution companies (LDC), intrastate and gathering pipelines or natural gas liquids (NGL) distribution.
Scheduler II	Performs advanced level of work related to nomination, confirmation, and scheduling activities for natural gas pipelines, local distribution companies (LDC), intrastate and gathering pipelines or natural gas liquids (NGL) distribution.
Scheduler III	Performs advanced level of work related to nomination, confirmation, and scheduling activities for natural gas pipelines, local distribution companies (LDC), intrastate and gathering pipelines or natural gas liquids (NGL) distribution.
Scheduler - Senior	Performs expert level of work related to nomination, confirmation and scheduling activities for intrastate and interstate transmission pipelines, storage, plants, gathering pipelines or natural gas liquids (NGL) distribution.
Supervisor – Engineering	Perform and supervise employees engaged in engineering and project management related to plant processing, fractionation and liquids handling, storage field, and transmission pipeline and compression including engineering, construction, regulatory compliance and budgets and schedules.
Supervisor - Pipeline Control	Coordinates and directs the flow of natural gas through the pipeline systems in a safe, reliable, compliant, and efficient manner. This includes transmission, gathering storage and



	processing systems. Flow analysis for operational design and commercial development projects.
Supervisor - Pipeline Operations	Supervises and directs employees engaged in activities related to maintenance, operations, and measurement of gathering and/or pipeline system.
Supervisor –Scheduling	Supervise employees engaged in activities related to nominations, confirmations and scheduling activities of natural gas or natural gas liquids for local distribution companies (LDC), intrastate, and gathering pipelines or NGL distribution through the pipeline systems. This includes transmission, gathering, storage and processing systems.
