Pursuant to Section 4 of the Natural Gas Act and Part 154 of the Federal Energy Regulatory Commission's ("Commission") regulations and the Commission's Order No. 587-AA<sup>1</sup> issued November 22, 2024, in Docket No. RM96-1-043, Viking Gas Transmission Company ("Viking") respectfully submits for filing and acceptance the tariff record listed below for inclusion in its FERC Gas Tariff, Volume No. 1 ("Tariff"). The proposed tariff record is submitted to become effective August 1, 2025.

Part 8, Section 25, NAESB WGO Standards, v. 6.0.0

### Statement of Nature, Reasons, and Basis for the Proposed Changes

On November 22, 2024, in Docket No. RM96-1-043, the Commission issued Order No. 587-AA (the "Order") amending Section 284.12 of its open access regulations, 18 C.F.R. § 284.12, governing standards for conducting business practices and electronic communications with interstate natural gas pipelines. Specifically, the Commission adopted, with certain enumerated exceptions, the latest version ("Version 4.0") of the consensus industry standards promulgated by the Wholesale Gas Quadrant ("WGQ") of the North American Energy Standards Board ("NAESB") by incorporating these standards by reference into its regulations.

The revised tariff record included herein reflects the Version 4.0 standards adopted by the Order and incorporated by reference into the Commission's regulations. Additionally, General Terms &

Conditions Section 25 of the Tariff reflects the format of the tariff provision set forth in the Sample Tariff Record issued by the Commission on November 25, 2024.<sup>2</sup>

### **Adoption of Standards**

Consistent with the requirements in Order No. 587-AA, Viking submits revisions to Section 25 of the General Terms and Conditions ("GT&C") of its Tariff to reflect the latest version of the NAESB standards adopted by the Commission.

Viking proposes to consolidate the standards from Books 4 and 10 into new Book 12. Viking also proposes to adopt by reference the modifications to existing referenced standards required by NAESB Version 4.0. Section 25 of the GT&C also has been revised to reference NAESB Version 4.0 and update NAESB's limited copyright waiver language.

### **Proposed Effective Date**

Pursuant to section 154.207 of the Commission's regulations and Order No. 587-AA,<sup>3</sup> Viking respectfully requests that these proposed tariff records be approved effective August 1, 2025. In accordance with section 154.7(a)(9) of the Commission's regulations, Viking hereby files a motion to place the proposed tariff records into effect at the end of any suspension period if one is so ordered by the Commission in this proceeding.

### **Waivers and Extensions of Time**

In accordance with the Commission's policy on waiver requests from Order No. 587-AA, Viking has not requested any additional waivers. Further, Viking has not requested an extension beyond August 1, 2025, for implementation of NAESB Version 4.0 Standards.

Pursuant to section 154.7(a)(7) of the Commission's regulations, Viking has not identified any additional waivers of the Commission's regulations needed to permit its filing to become effective as proposed; however, Viking respectfully requests that, should the Commission determine that any such waivers are required, the Commission grant such waivers as are necessary in order that the revised tariff record may be made effective as proposed.
