Summary Annual Report for EnLink Midstream Operating, LP 401(k) Trust

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan of EnLink Midstream Operating, LP 401(k) Trust, EIN 11 3666506, for January 01, 2024 through December 31, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single-employer 401(k) plan.

Basic financial statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$39,300,389. These expenses included \$183,641 in administrative expenses, \$39,116,748 in benefits paid to participants and beneficiaries and \$0 in other expenses. A total of 1,436 persons were participants in, or beneficiaries of, the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$210,482,860 as of December 31, 2024, compared to \$201,693,534 as of January 01, 2024. During the plan year, the plan experienced an increase in

its net assets of \$8,789,326. This increase includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of plan's assets at the end of the year and the value of the assets at the beginning of the year or cost of assets acquired during the year. The plan had a total income of \$48,089,715, including employer contributions of \$7,979,780, employee contributions of \$12,136,974, gains of \$0 from the sale of assets, and earnings from investments of \$26,131,980.
