We are committed to the quality of our sports cars, and every Porsche is a sports car. This is why the Porsche Approved Warranty policy is available for Porsche vehicles up to 15 years old.*

The Porsche Approved Warranty covers the repair or replacement of any defective part with Porsche Genuine Parts free of charge. For full policy details, see terms and conditions.

A Porsche Approved Warranty offers:

- Worldwide cover
- All repair or replacement costs are covered, including parts and labour
- No excess to pay
- No mileage limit during the warranty period
- Porsche Genuine Parts used in repairs
- Optional duration of 12, 24 or 36 months
- Coverage for Porsche vehicles up to 15 years old

A Porsche Approved Warranty can be purchased from Porsche Centres for any Porsche that meets the eligibility criteria; either to extend an existing Porsche Approved Warranty or the Porsche New Car Warranty, or where a car does not have any existing cover.

The 12, 24 or 36 month Porsche Approved Warranty is available for all Porsche cars (excluding Carrera GT and 918. For full exclusions, please refer to the terms and conditions) less than 14, 13 or 12 years old respectively.

It is only possible to have two additional registered future Porsche Approved Warranty options, with the mileage at the time of purchase not exceeding 200,000 km.

Conditions for granting a Porsche Approved Warranty.

- Porsche standard-production vehicles* not older than 14 years with a mileage less than 200,000 kilometres.
- All service tasks must be performed by a Porsche Partner and documented as specified in the Warranty & Maintenance booklet**.
- A mandatory 111-point inspection must be performed. Any faults detected have to be rectified prior to acceptance onto the programme.
- The vehicle must not have been modified or misused in a manner that is not approved by the manufacturer.
- A minimum of 90 days ownership, in case of Stand-alone Warranty.
- Not intended for commercial operation involved in selling cars, a leasing company, a vehicle rental or a passenger transport business.

*The Porsche Approved Warranty is available for all Porsche cars (excluding Carrera GT, 918 Spyder, Porsche Cup Cars).

**If the service interval was not followed, a major service must be performed.



Stand-alone Warranty.



The purchase of a Porsche Approved Warranty following the expiry of the New Car Warranty or existing Porsche Approved Warranty is referred to as a Porsche Approved Stand-alone Warranty.

To be eligible, you must have owned your car for at least 90 days and a 111-point inspection must be carried out on your car by a Porsche Centre.

The 111-point inspection may be charged for in addition to the cost of the Approved Warranty and any car faults identified during the inspection will need to be repaired prior to a Porsche Approved Warranty being issued.

The 111-point check will be valid for 180 days or 250 kilometers (155 miles). Porsche Approved Warranty includes Porsche Roadside Assistance.

Warranty Extension.

If your Porsche has an existing New Car Warranty or Porsche Approved Warranty, this may be extended until the car is 14 years old for a 12 month policy, 13 years old for a 24 month policy, or 12 years old for a 36 month policy.

A 111-point inspection is not required for a Warranty Extension. A Warranty Extension can be purchased whilst the existing policy is live. Once expired, a Warranty Extension can be purchased up to 30 days within the expiry.

The warranty covers the operational functionality of all parts belonging to the following vehicle components:

Engine

- Exclusions – spark plugs, drive belt, deflection and tensioning roller

Power train / Transmission

- Exclusions – clutch disc and pressure plate

Suspension / Steering

- Exclusions – shock absorbers, tyres, tyre sealant, PDCC reservoir

Brake system

- Exclusions – brake pads, brake discs

Heating / Air conditioning

- Exclusions – refrigerant gas

Electrics

- Exclusions – all bulbs, (excluding Xenon and LED lamps) fuses, wiper blades, batteries

Body

- Exclusions – floor mats, fire extinguisher, etc.

Other exclusions – All filters, fluids, oils and greases.

Like your car, we want to ensure your Porsche Approved Warranty also stands for reliability and trust. This means openly stating what will not be covered under a Porsche Approved Warranty and why.

As your Porsche ages, it can undergo visual and acoustic changes without affecting its functionality (e. g. worn leather). Also, certain parts are subject to ageing and natural wear. For this reason, your Porsche has scheduled service and maintenance intervals. Visual and acoustic concerns, wear and tear are not defects and are therefore excluded from the warranty.

Replacement of parts subject to ageing and wear and tear

- Damage caused by ageing and natural wear and tear is not covered and always excluded by the Porsche Approved Warranty.
