## PFAS

SASOLWAX products are not expected to contain per- and polyfluoroalkyl substances (PFAS). PFAS are not intentionally added during our manufacturing processes.\*

## Microplastics

Sasol's GTL Fischer-Tropsch waxes are non-polymeric paraffin and hydrocarbon waxes (CAS RN 8002-74-2) and do not meet the definition of microplastics.\*

# MOSH/MOAH

Sasol's GTL Fischer-Tropsch waxes are synthetic. They are manufactured from carbon monoxide and hydrogen, resulting in saturated straight-chain hydrocarbons that do not originate from mineral oil. They do not contain any aromatic portion; however, they may contain some minor concentrations of shorter chain length paraffin that do not originate from oil derivatives.\*
