Purposes of the processing of personal data by SLOVECA

- > identification of visitors physical persons at a one-time entry into area of the controller
- protection of the rights and legitimate interests of the controller or persons located in the objects of the controller

Legal basis

The legal basis for the processing of personal data is a legitimate interest that is protection of rights and legally protected interests of the controller as well as persons located in the objects of the controller.

Categories of recipients to whom personal data may be provided

persons authorized to carry out activities for SLOVECA

Transfer of personal data to a third country

SLOVECA as a controller does not intend to transfer personal data to a third country or international organization.

Period of retention of personal data

SLOVECA is authorized to process the personal data of affected persons (i) for a period specifically determined by the applicable law and (ii) for the duration of the purpose of the processing.

Rights of an affected person

- > right to request SLOVECA for access to their personal data,
- > right to correct personal data,
- > right to delete ('right to be forgotten')
- > right to restrict processing of personal data
- > right to object to the processing of personal data
- right to portability of personal data
- right to apply for opening of proceedings to the supervisory authority, the Office for the Protection of Personal Data of the Slovak Republic

The rights of an affected person are specified in detail in Articles 15 to 21 of the GDPR. Affected person shall apply the rights in accordance with the GDPR and other relevant legislation. Rights of the affected person to SLOVECA can be applied by written application or by electronic means. If required by the affected person, the controller may provide the information also verbally assuming that identity of the affected person is proved another way.
