# Department of Transport and Planning – Transport Victoria Open Data Portal Terms of Use

These Terms of Use (**Terms**) govern your use of our Transport Victoria Open Data Portal located at <a href="https://opendata.transport.vic.gov.au">https://opendata.transport.vic.gov.au</a> (**Portal**) and form a binding contractual agreement between you, the user of the Portal and us, the Department of Transport and Planning (ABN 69 981 208 782) ("we", "us" or "DTP"). DTP is a government department that is responsible for planning, building, operating and maintaining transport within Victoria. This Portal is a consolidated portal that contains data relating to Victoria's public transport and road networks.

By using the Portal, you acknowledge and agree that you have had sufficient chance to read and understand these Terms and you agree to be bound by them. If you do not agree to the Terms, please do not use the Portal.

These Terms may be modified from time to time, and you should regularly review them. Your continued use of the Portal constitutes your agreement to any modified Terms.

## 1. LICENCE TO USE PORTAL

- 1.1 We grant you a limited, non-exclusive, non-transferable, non-sublicensable licence to use the Portal in accordance with these Terms.
- 1.2 You may access and use the Portal in the normal manner.
- 1.3 You agree that you will not use this Portal to:
  - (a) discriminate, threaten or intimidate any person or entity;
  - (b) engage in any defamatory acts that would bring us into disrepute;
  - (c) carry out pornographic or offensive activities;
  - (d) transmit or distribute a virus, trojan, worm, logic bomb or any other material which is malicious, technologically harmful, in breach of confidence or in any way offensive or obscene;
  - (e) hack into any aspect of the Portal or DTP's systems or corrupt data;
  - (f) infringe upon the rights of any other person, including intellectual property rights;
  - (g) interfere with, hinder the operation of or make unauthorised modifications to the Portal:
  - (h) send any unsolicited advertising or promotional material, commonly referred to as "spam".

    - (i) you breach any provision of these Terms;
    - (ii) DTP is unable to verify or authenticate any information that you provide to us; or
    - (iii) DTP believes that your actions may cause damage and/or legal liability to DTP or any of its customers or suppliers or any other person; and/or
  - (b) remove or block access to any information and/or materials (in whole or in part) that DTP, at its sole and absolute discretion, regards in any way to be objectionable or in violation of any applicable law, any person's intellectual property rights or these Terms.
