The form will need to be uploaded to transport.vic.gov.au, along with the supporting documentation to support your exemption application. You will have to pay a fee when you submit your documents. Once the application is submitted, you will receive a confirmation email from the Department of Transport and Planning.

2. A non refundable application fee is payable to the Department of Transport and Planning. This fee is for processing your application.

I hereby state that the vehicle to be licenced complies with the tow truck specifications, maintenance and equipment requirements as listed below.

Tow truck specifications, maintenance and equipment requirements:

- 1. The operator of a tow truck must ensure that the tow truck:
 - (a) has a load capacity of at least 1.25 tonnes;
 - (b) has dual tyres on each side of each axle on the wheels or the rear axle group;
 - (c) is fitted with a crane which complies with the Vehicle Standards Bulletin 6 (VSB6) or a winch, hoist, ramp or other lifting device which has a safe working load of not less than 1.25 tonnes;
 - (d) is equipped with a broom, shovel and durable rubbish receptacle for the removal of debris and glass from highway;
 - (e) is equipped with either a fully maintained foam fire extinguisher of at least 4.5 litres capacity or a dry chemical powder fire extinguisher of at least 4.5 kilograms capacity;
 - (f) is fitted with a flashing or rotating amber warning lights or lights approved by the licensing authority; and
 - (g) is fitted with two (2) fully adjustable lights mounted so that the operator will have sufficient illumination to safely load or unload a damaged motor vehicle when it is dark.

- **2.** (a) The operator of a tow truck must ensure that there is displayed on the tow truck in a permanent form:
 - on the right hand door, in contrasting letters and numerals a minimum of 50 millimetres high and proportionally wide and clearly visible from a distance of at least 5 metres:-
 - the owner's name and address.
 - (b) if the authorised depot is in the controlled area and the licensing authority allocates a depot number on both front doors, in contrasting letters and numerals 100 millimetres high and proportionately wide and clearly visible from a distance of at least 20 metres, the word "depot" followed by depot number.
- **3.** The operator of a tow truck must ensure that the equipment required to be fitted to a tow truck is maintained in a serviceable condition.
