- 1. The operator of a tow truck must ensure that the tow truck:
 - (a) has a load capacity of at least 1.25 tonnes;
 - (b) has dual tyres on each side of each axle on the wheels or the rear axle group;
 - (c) is fitted with a crane which complies with the Vehicle Standards Bulletin 6 (VSB6) or a winch, hoist, ramp or other lifting device which has a safe working load of not less than 1.25 tonnes;
 - (d) is equipped with a broom, shovel and durable rubbish receptacle for the removal of debris and glass from highway;

- (e) is equipped with either a fully maintained foam fire extinguisher of at least 4.5 litres capacity or a dry chemical powder fire extinguisher of at least 4.5 kilograms capacity;
- (f) is fitted with a flashing or rotating amber warning lights or lights approved by the licensing authority; and
- (g) is fitted with two (2) fully adjustable lights mounted so that the operator will have sufficient illumination to safely load or unload a damaged motor vehicle when it is dark.
- The operator of a tow truck must ensure that the equipment required to be fitted to a tow truck is maintained in a serviceable condition.
