

Application to conduct a non-road activity on a highway

You are applying for a permit to conduct a non-road activity on a highway under the *Road Safety Act 1986*. To facilitate a non-road activity authorised by a permit, Department of Transport and Planning may authorise the closure of the highway to all traffic or to particular types of traffic for the period specified in the permit. A permit may be issued subject to:

- any terms, conditions or limitations which Department of Transport and Planning, as the coordinating road authority, considers appropriate; and
- the payment of a fee specified in the Act.

You may also be applying for authorisation to erect, display, place, remove or alter Traffic Control Devices as specified below, under the Road Safety (*Traffic Management Regulations 2019*). If so, you agree and acknowledge that:

- the Traffic Control devices must be installed and removed as outlined in relevant sections below, unless further authorisation has been granted;
- accurate records of actual usage of the Traffic Control Devices will be kept in a document which can be provided to Department of Transport and Planning (e.g. a diary);
- the attached plans are a true and accurate reflection of the base information and proposed treatments; and
- the treatments shown on the plans are in accordance with the Worksite Safety Traffic Management – Code of Practice.

Please complete the section below, attach any supporting documentation, sign and return to the appropriate Department of Transport and Planning Office (listed on back of application) and to the Transport Accident Commission (TAC). All fields must be completed in order to process your application.

Application process

Should you go ahead with your event without obtaining all the necessary authorisations, you will be committing an offence and will be subject to prosecution, as well as the termination of the Event by the Victoria Police only if there is a risk to property or life. In other circumstances, Victoria Police will intervene and this may result in the event being ended. Except for filming applications, which usually need to be expedited, you should allow 60 days for your application to be approved. This time guide is indicative only and does not allow for any preliminary work that should have been undertaken prior to the lodgement of your application.

For any Event significantly impacting upon the road network, DTP will require evidence of at least \$20 million public liability cover. The insurance policies must note "Head, Transport for Victoria" and "Department of Transport and Planning" as an interested party for the term of the road related Event. A copy of each insurance policy must be included in your application to use a DTP road.

DTP does not charge a fee for most applications, but would appreciate acknowledgement of its assistance with this application on the event website or other event publicity.

If you are able to provide such an acknowledgement, check the box below to be provided with DTP logo for these purposes. The logo may only be used on the event website or other event publicity, to denote a contribution to the running of the event.
