# Pre-approval application for Licensed Vehicle Tester (LVT) licence



You'll need to complete the pre-approval application and submit all the required documents. We'll then assess your eligibility to continue to the next steps of the application process. You can view all the required steps of the application at **transport.vic.gov.au**.

You still need to apply for a LVT licence even if you have purchased a previously licensed LVT workshop, as a LVT licence can't be transferred to the new business owner.

We've got the right to refuse any application to become a LVT, particularly if we deem the applicant isn't meeting any or all the requirements noted in the application.

Before you begin your application, you need to read the Licensed Vehicle Tester's Licence Conditions at **transport.vic.gov.au**.

Applications will be accepted from a retail motor vehicle mechanical workshop.

Incomplete applications will be rejected and a new application will need to be submitted with an additional payment.

### Are you eligible to become a LVT?

You need to give us an original National Police Certificate from Victoria Police or Australian Federal Police (issued within the last three months) with the pre-approval application. Please be aware this can take up to six weeks to obtain. Third party police checks will not be accepted and applications will be declined and returned.

A criminal record may affect your ability to be granted a LVT licence. All Company Directors and individuals that have had charges or offences recorded, or been convicted within the last 10 years or have any outstanding charges listed below will be declined and the application returned:

- any offences which indicates poor judgement of character or dishonesty
- any offences in relation to violence, drugs or firearms
- offences relating to vehicle crime
- failing to notify police while being the driver of a vehicle which was involved in an accident which resulted in the injury of persons or damage to property
- an offence involving the risk of injury to the public.

You will also need:

- to hold a current and valid Victorian driver licence
- to ensure that all staff nominated for inspection and testing duties have a minimum of seven years mechanical experience for the type of vehicle in your nominated testing category.

### For an individual operating own workshop:

- Certified copy of your mechanical qualifications specific to the nominated categories of vehicles to be tested. If your qualification has been attained through recognised prior learning (RPL), ensure you submit your statement of results to support your qualification. Evidence of practical based learning modules must be included
- A detailed outline of history as a motor mechanic involved in the repair and inspection of motor vehicles in the nominated testing category, indicating a minimum of seven years experience, including verifiable references
- Detailed layout of the floor plan of premises/workshop and designated four off-street parking bays, which must be suitable for the category of vehicle to be tested. Note that parking in the workshop area is not permitted
- Completed pre-application workshop inspection checklist on page three
- Photos, in colour and clear, of workshop including: building exterior, customer parking area that shows four off-street parking bays which must be suitable for the category of vehicle to be tested (parking in the workshop area is not permitted), main workshop entrance, hoist area, an enclosed and separate customer service area and reception showing a minimum of two seats. Send as many photos showing different angles that would help us view your workshop and premises. There must be a separate entrance to the waiting room. Entry via the workshop is not permitted
- Certified copy of a lease or rate notice of premises. Shared premises are not accepted and applications will be returned. Lease to specify permitted use and allocated parking bays
- Payment for pre-approval application. Check the website for the current fees. If your application is successful, you need to also pay the Licence Start-Up Kit Fee.

### For a company application:

Along with this application form, you need to submit the following:

- Original National Police Certificate from Victoria Police for all company directors and shareholders
- Company extract from ASIC, confirming business directorship/ownership.

  If there is ownership of a second, third, etc. companies, we require all ASIC extracts for each company. Application is to be in the name of the major shareholder
- Outline of company structure organisational flow chart
- Detailed floor plan layout of premises/workshop and designated four off-street parking bays which must be suitable for the category of vehicle to be tested. Note that parking in the workshop area is not permitted
- Completed pre-application workshop inspection checklist on page three
- Photos, in colour and clear, of workshop including: building exterior, customer parking area that shows four off-street parking bays which must be suitable for the category of vehicle to be tested (parking in the workshop area is not permitted), main workshop entrance, hoist area, an enclosed and separate customer service area showing a minimum of two seats. Send as many photos showing different angles that would help us view your workshop and premise. There must be a separate entrance to the waiting room. Entry via the workshop is not permitted
- Certified copy of a lease or rate notice of premises. Shared premises will not be accepted and applications will be returned. Lease to specify permitted use and allocated parking bays
- Payment for pre-approval application. Check the website for the current fees. If your application is successful, you need to also pay the Licence Start-Up Kit Fee.

## For each additional employee nominated as testing staff as part of your licence pre-application, you'll need the following:

- A list of all nominated testing staff including a copy of their driver licence numbers on a company letterhead
- An original National Police Certificate from Victoria Police\* or Australian Federal Police
- A certified copy of their mechanical qualifications specific to the nominated categories of vehicles to be tested. If their qualification has been attained through recognised prior learning (RPL), ensure you submit their statement of results to support their qualification. Evidence of practical based learning modules must be included
- A detailed chronological outline of history as a motor mechanic involved in the repair and inspection of motor vehicles in the nominated testing category, indicating a minimum of seven years experience, including verifiable references.

\*Note: Non-Victorian applicants will need to apply for a National Police Certificate in the jurisdiction of their address. Overseas applicants must apply for a National Police Certificate issued by the Australian Federal Police. No other certificates will be accepted.
