SUSTAINABILITY POLICY

EAST Hong Kong is committed to achieving best practice environmental and social sustainability and has partnered with EarthCheck, the world's leading Benchmarking and Certification provider.

EAST Hong Kong is a hotel sitting on 689.3 m² of land in an inner city environment located at 29 Taikoo Shing Road, Taikoo Shing, Hong Kong (22.286126, 114.216007). The property is bounded by Taikoo Shing to the North and to the West, Cityplaza Shopping Mall to the East and Kornhill Gardens to the South.

It consists of 325 guestrooms and 6 suites over 32 levels, a cafe/co-working space "Domain", a restaurant "Feast" and a harbour-view rooftop bar "Sugar", along with a gym "Beast" and an outdoor swimming pool.

The closest water body is Eastern Victoria Harbour, approximately 450 metres to the north of the hotel. EAST Hong Kong is located in a mixed-use residential and commercial area which plays a significant role in the cultural and economic landscape of Hong Kong.

EAST Hong Kong is a 331-room accommodation complex in the dynamic district of Taikoo Shing, Hong Kong. The hotel includes modern guestrooms, suites, meeting facilities, a signature restaurant, a rooftop bar, a gym, and an outdoor swimming pool, catering to both business and leisure travelers. While located in an urban setting, the hotel is within proximity to Eastern Victoria Harbour and is surrounded by both residential and commercial developments.

At EAST Hong Kong, we recognise that the activities of our hotel have the potential for negative impacts on the environment and community if not properly managed. As such, we have implemented an Environmental Management System that meets the requirements of the EarthCheck Company Standard.

EAST Hong Kong is committed to continual improvement, measured by way of annual Benchmarking Assessments. The team at EAST Hong Kong strives towards minimising our environmental footprint by implementing sustainable initiatives aimed at improving the hotel's performance, reducing the use of energy and water, and minimising waste production.

EAST Hong Kong will comply with all relevant legislation and regulations and aims to achieve international best practice standards. We have appointed Ms Nina Yeung, as the EarthCheck Coordinator, who is responsible for improving the hotel's sustainable performance.

Special consideration will be given to employing and empowering local employees, and wherever possible, sustainable products and services will be sourced locally in accordance with Fair Trade principles.

Our commitment to environmental and social sustainability is communicated to all key stakeholders, including guests, suppliers, and contractors, to align our operations with sustainable best practices.
