Data Monitoring and Multi-site Coordination (when all subjects in Follow-up) Annual Maintenance Fee:

The Quality Unit will support Investigator Initiated Trials by conducting reviews of data entered into the trial's database. Trials with all patients in long-term follow up will be invoiced a distinct fee. Reflecting the nature of limited data to be reviewed.

1. *Start Up Fee will be invoiced after the protocol is activated as open to accrual.*
2. *Single Site Trial include trial also open at any UChicago Medicine Network Site. Includes all complexities.*
3. *Registration Fee will be initially invoiced 6 months after the trial has been open to accrual.*
4. *Monitoring and Data Coordination Fee will be initially invoiced 6 months after the trial has been open to accrual.*

Question	Answer
Can the fees be lowered for unfunded trials?	All trials will be invoiced in accordance with the approved recharge fees.
