NOV	30 <sup>th</sup>	Annual Registry Fee for 2nd Half Year Companies Applicable to all companies incorporated between 1 July and 31 December	
DEC	<b>31</b> <sup>st</sup>	CbCR Initial Notification & CbCR Report for entities with FYE 31 December Applicable to multinational enterprises that meet criteria	•
Ongoing		Economic Substance Filing Applicable to all relevant entities (deadlines vary)
