Trip interruption

Trip interruption coverage for food and lodging for up to three days – up to specified limit – if breakdown occurs more than 100 miles from home.



Transportation reimbursement

In conjunction with covered repairs – up to a specified daily limit.

Control module, transmitter/receiver, switches, speaker

Sensors, alert devices, control unit, switches, actuators



Tire Pressure Monitoring (TPMS) System

Sensors, module, receiver, switches



Navigation System

Display, control module, GPS antenna, switches



Wi-Fi Data Connection System

Transmitter, receiver, module, switches, antenna



Keyless Access and Remote Start System

Control module, transmitter/receiver, key fob, actuators, key panel, starter motor, entry motors, sensors, switches



Blind Spot/Lane Departure/Parking Assist System(s)

Forward, backup and 360 degree camera(s), sensors, control unit, haptic/alert module, warning devices, switches



Touch/Display Screen System

Infotainment system, media display(s), HVAC control panel, instrument panel, back-up camera display, heads-up display (HUD), switches

- ✗ Repairs covered by any other insurance policy, service contract, written warranty, or covered by a manufacturer's or repairer's guarantee
- ✗ Damaged cause by using your vehicle as a stationary power source
- ✗ Damaged caused by non-factory software including virus, malware, spyware
