Eligible Vehicles:*

Only on-road/street use motorcycles and scooters qualify for tire & wheel contracts.

*Some makes and models may not be eligible, please ask your dealership for more information.

Ineligible Vehicles:

Off-road, dual purpose, or competition motorcycles and all ATVs.



What's Covered?

Tires - repair or replacement of damaged tires due to a road hazard

Wheels - repair or replacement of wheels (if tire cannot seal air after the tire was repaired or replaced)

Additional fees and taxes - mounting, balancing, valve stems and applicable taxes in conjunction with a covered repair

Pickup reimbursement - reimbursement (up to specified limit) for motorcycle/scooter pick up and delivery to a repair facility - if tire or wheel damaged due to road hazard

What's not covered?

(See your contract for full list of exclusions)

- Any repair or replacement made without prior authorization
- Tires with less than 3/32" tread depth remaining
- Tire or wheel that has not sustained damage due to a road hazard
- Any repairs covered by manufacturer, other service agreement or primary insurance, etc.
- Damaged caused by sidewall/curb impact, rim pinches, improper inflation, accident or collision, off-road/unpaved road use

 Damage sustained prior to purchase of contract

Ask your selling dealership for more information.

- No deductible
- No maximum number of occurrences
- No mileage limitations
- All eligible tires are covered (at least 3/32" of tread required at the time of damage)
- Transferable to the next vehicle owner
