What is happening?

We have been notified by the director of FTGF, that the Directors decided to approve certain amendments to the Underlying Fund. Details of the significant amendments being made to the Underlying Fund are listed below.

The amendments to the Base Prospectus and the Supplements of the Underlying Fund will take effect on the date on which the revised Base Prospectus and the revised Supplements of the Underlying Fund are approved by the Central Bank of Ireland (the "**Effective Date**"). The Effective Date will be on or around May 31, 2024. The Hong Kong Offering Documents will be updated to reflect the changes as set out herein, as well as other miscellaneous updates, drafting and/or editorial amendments, on or after the Effective Date.
