We are writing to let you know about the change to BNP and the Underlying Fund. You have invested in the investment choice corresponding to the Underlying Fund, which is listed in the "Which investment choices are affected?" table below under the column "Name and code of the investment choice".

### What is happening?

We have been notified by the board of directors of BNP of the following amendments which will be reflected in the next version of the Hong Kong offering document of BNP. The below change will be effective on June 28, 2024.

The investment manager of the Underlying Fund intends to invest in debt securities traded on the Bond Connect, in addition to debt securities traded on the China Interbank Bond market.

As a result, the third paragraph of the investment policy of the Underlying Fund will be amended to read as follows:

"In respect of the above investments limits, the sub-fund's investments into debt securities traded on the China Interbank Bond market **and the Bond Connect** may reach up to 25% of its assets."



In addition, a risk factor linked to the Bond Connect will be added to the risk profile section of the Underlying Fund.

This new wording will not have any impact on the risk profile of the Underlying Fund.

The change above will not result in any increment in fees level or costs in managing the Underlying Fund. In addition, no costs or expenses will be incurred in connection with the changes. The changes would not materially change the features and overall risk profile of the Underlying Fund. There would be no change in the operations or the manner in which the Underlying Fund is being managed. Further, the change would not materially prejudice the existing investors' rights of interest.

The Hong Kong Offering Document of BNP will be updated to reflect the change above. The current Hong Kong Offering Document of BNP is available on the website at https://www.bnpparibas-am.com/en-hk1. The updated Hong Kong Offering Document of BNP will be available later.

#### What does this mean to you?

If you wish to continue to invest in the Investment Choice after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice, you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

新措詞不會對該相關基金的風險範圍產生任何影響。

上述變動將不會導致管理該相關基金的費用水平或成本增加。此外,變動不會招致任何成本或開支。變動不會顯著改變該相關基金的特點及整體風險範圍。該相關基金的運作或管理方式並無改變,亦不會顯著損害現有投資者的權利或權益。
