#### What is happening?

We have been notified by the Board of Directors of SISF that the following changes or updates to the Hong Kong offering documents of the SISF and the Underlying Funds, comprising the Prospectus and Hong Kong Covering Document of SISF and the Product Key Facts Statements of the Underlying Funds ("Hong Kong Offering Documents").

## I. Change of investment policy of Schroder International Selection Fund - Asian Local Currency Bond

The investment policy of Schroder International Selection Fund - Asian Local Currency Bond has been updated to provide that the Underlying Fund may invest up to 30% of its assets directly in mainland China through (i) the QFI scheme or QFI related schemes supervised by the China Securities Regulatory Commission provided investment restriction 1.(A) (5) (I) of Appendix I of the Prospectus is complied with and/or they qualify as Investment Funds and (ii) Regulated Markets (including the CIBM via Bond Connect or CIBM Direct).

### II. Enhancement / clarification to the investment policies of the Underlying Funds

The investment policies of certain Underlying Funds have been enhanced or clarified. Please refer to the Appendix for details of the amendments.

### V. Miscellaneous updates / changes

Additional changes have also been made to the Hong Kong Offering Documents, including the following:

- update of disclosures relating to SFDR pre-contractual disclosures for each Underlying Fund that has environmental and/or social characteristics (within the meaning of Article 8 SFDR) or has the objective of sustainable investment (within the meaning of Article 9 SFDR) information about such characteristics or objective and Taxonomy;
- (b) clarification of dealing arrangement to reflect existing practice, i.e. fractional entitlements to registered Shares will be rounded to two decimal places;
- (c) clarification of distribution arrangement to reflect existing practice, i.e. fractional entitlements to registered Shares will be rounded to two decimal places (unless otherwise agreed with the Management Company);
- (d) update to provide that an Underlying Fund will not hold more than 5% of its assets in special purpose acquisition vehicles unless specified in the investment policy;
- (e) enhancement of disclosures on Schroders' proprietary sustainability tools;
- (f) enhancement of disclosures relating to the QFI regime;
- (g) update of disclosures relating to Stock Connect;
- (h) enhancement of risk disclosures (including risk disclosures relating to the Science and Technology Innovation Board and/or ChiNext market, sustainability risks, convertible bonds, RMB currency risk and RMB Share Classes related risk, risk relating to the Stock Connect and risk relating to Distribution Share Classes with fixed dividend policy) and addition of risk factors (including risks linked to special purpose acquisition vehicles);
- (i) update of the profiles of the directors of SISF and the Management Company;
- (j) update to reflect the change of independent auditors; and
- (k) other clarifications, miscellaneous updates, changes and editorial amendments.



Save as disclosed above, SSIF confirms that in relation to the amendments or changes set out above:

- there are no changes to how the Underlying Funds are managed;
- the investment style, investment philosophy and risk profile of the Underlying Funds remain the same; and
- the fees chargeable in respect of the Underlying Funds as stated in the Hong Kong Offering Documents remain the same.

#### What does this mean to you?

If you wish to continue to invest in the Investment Choice(s) after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice(s), you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

The sustainability criteria of each of the Underlying Funds have been clarified to provide that each of the Underlying Funds maintain a higher overall sustainability score than the Underlying Funds' respective investment universe, based on the Investment Manager's rating system.

2. Schroder International Selection Fund - Asian Local Currency Bond - Update to the investment policy

The investment policy of Schroder International Selection Fund - Asian Local Currency Bond has been updated to remove the 5% limit in PRC onshore investment traded on the CIBM via Bond Connect.

3. Schroder International Selection Fund - EURO Corporate Bond - Update to the name of the benchmarks

The target benchmark of Schroder International Selection Fund - EURO Corporate Bond has been updated to remove "Merrill Lynch" from the names of the benchmark for clarity. For the avoidance of doubt, there is no change to the actual benchmark of the Underlying Fund.

4. Schroder International Selection Fund - Global Climate Change Equity, Schroder International Selection Fund - Global Sustainable Food and Water, Schroder International Selection Fund - Healthcare Innovation, Schroder International Selection Fund - Sustainable Multi-Asset Income - Clarification of sustainability criteria

The sustainability criteria of each of the Underlying Funds have been clarified to provide that the Investment Manager ensures that at least 90% of the portion of each of the Underlying Funds' Net Asset Value composed of investments in companies is rated against the sustainability criteria.

5. Schroder International Selection Fund - Global Sustainable Food and Water - Update of investment policy

The investment policy of Schroder International Selection Fund - Global Sustainable Food and Water has been updated to remove disclosures that the Underlying Fund invests at least 75% of assets in sustainable investments. The investment policy of the Underlying Fund has been further updated to provide that the Underlying Fund invests at least 90% of its assets in the relevant sustainable investments as disclosed in the Hong Kong Offering Documents and may invest in investments that the Investment Manager deems to be neutral under its sustainability criteria.

6. Schroder International Selection Fund - Global Climate Change Equity - Enhancement of disclosures in relation to the use of comparator benchmark

The disclosures in relation to the use of comparator benchmark have been enhanced to clarify that the comparator benchmark is also used for sustainability score comparison.

7. Schroder International Selection Fund - Sustainable Multi-Asset Income - Enhancement of investment policy

The investment policy of Schroder International Selection Fund - Sustainable Multi-Asset Income has been enhanced to provide that the Underlying Fund may invest up to 10% of its assets in mainland China through Regulated Markets (including the CIBM via Bond Connect or CIBM Direct).



8. Schroder International Selection Fund - Global Sustainable Food and Water - Enhancement of sustainability criteria

The sustainability criteria of the Underlying Fund have been enhanced to provide further details on the composition of the Underlying Fund's investment universe.

## I. 更改施羅德環球基金系列 - 亞幣債券的投資政策

施羅德環球基金系列 - 亞幣債券的投資政策已作出更新,以規定該相關基金可將最多30%的資產通過(i)中國證券監督管理委員會監管的QFI計劃或QFI相關計劃,前提是必須符合發行章程附件I內投資限制I. (A) (5) (I)和 / 或合資格成為投資基金,及(ii)受監管市場(包括通過債券通或中國銀行間債券市場直接投資模式投資中國銀行間債券市場)直接投資於中國內地。

# Ⅱ. 該等相關基金的投資政策的加強披露 / 澄清

各該等相關基金的可持續標準已作出澄清,以規定投資經理確保各該等相關基金由公司投資組成的資產淨值中,至少**90%**將按照可持續標準評級。
