Dear valued customer.

We are writing to let you know about the changes to the Underlying Fund. You have invested in an investment choice corresponding to the Underlying Fund, which is listed in the "Which investment choices are affected?" table below under the column "Name and code of the investment choice".

What is happening?

We have been notified by the Board of CT of an amendment to the investment policy of the Underlying Fund. The amendment has been brought forward to strengthen the promotion of environmental and social characteristics within the meaning of Article 8 under the Sustainable Finance Disclosure Regulation (the "SFDR").

The amended investment policy and SFDR RTS Annex (Regulatory Technical Standards relating to the Sustainable Finance Disclosure Regulation) will be adopted from September 2, 2024 ("Effective Date").

The Underlying Fund already promotes environmental and social characteristics by integrating a range of responsible investment measures into the investment decision-making process, as well as ensuring that the companies in which the Underlying Fund invests follow good governance practices.



From the Effective Date, the Sub-Advisor responsible for the management of the Underlying Fund will increase the minimum proportion that the Underlying Fund commits to holding sustainable investments, as further detailed in the SFDR RTS Annex.

The current and revised minimum proportion of sustainable investment are set out in the following table:

Underlying Fund	Current minimum proportion of assets in sustainable investments	Minimum proportion in sustainable investments from the Effective Date
Columbia Threadneedle (Lux) I - CT (Lux) Global Focus	5%	20%

Following the introduction of SFDR, investors are increasingly requiring investment funds to embed the promotion of environmental and social characteristics into their investment process. These changes strengthen the binding commitments already being made by the Underlying Fund, and increase the suitability for investors with certain sustainability preferences under MiFID II (the Markets in Financial Instruments Directive and Markets in Financial Instruments Regulation - collectively known as MiFID II).

Please note that they do not expect these amendments to the investment policy to result in significant changes to the way in which the Underlying Fund is currently managed or its risk profile.

The current Hong Kong offering documents of CT, the articles of association of CT and the most recent annual and semi-annual reports are available on the website www.columbiathreadneedle.com¹. The updated version of the SFDR RTS Annex which will reflect the changes detailed above will also be available (in English language only) free of charge on the website www.columbiathreadneedle.com¹ in due course.

What does this mean to you?

If you wish to continue to invest in the Investment Choice after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice, you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

修訂事項

CT的董事會已通知我們,其現正修訂該相關基金的投資政策。這次修訂旨在加強推動可持續金融披露規例(「SFDR」)下第8條所指的環境及社會特徽。

經修訂的投資政策及SFDR RTS附錄(有關可持續金融披露規例的監管技術標準)將由2024年9月2日(「生效日期」)起採納。

該相關基金已透過將一系列負責任投資措施整合至其投資決策過程,以及確保該相關基金所投資的公司遵循良好管治實踐來推動環境及社會特徵。

由生效日期起,負責管理該相關基金的代理顧問將提高該相關基金承諾持有可持續投資的最低比例,進一步詳情載於SFDR RTS附錄。

在推行SFDR後·投資者越益要求投資基金將推動環境及社會特徵納入至其投資過程。此等更改加強已由該相關基金作出的具約束力的承諾·並提高對MiFID II(歐盟金融工具市場指令及金融工具市場規例-統稱MiFID II)下具有若干可持續性偏好的投資者的適用性。
