What is happening?

We have been notified by Fidelity about developments taking place within Fidelity impacting the Underlying Funds. As part of their ongoing commitment to responsible and sustainable investing, they are updating their approach to Sustainable Investing and environmental, social and governance ("**ESG**") integration, to reflect the evolving sustainable investing landscape and enhance transparency to investors.

With effect from July 30, 2024, the following updates to the Hong Kong Offering Documents and the Underlying Funds will be made.



I. Introduction of Environmental, Social and Governance (ESG) scores for portfolios

They will be introducing ESG portfolio scores to promote environmental and social characteristics of certain Underlying Funds.

The following Underlying Funds will aim to have an ESG score greater than that of their investment universe or benchmark.

- Fidelity Funds America Fund
- Fidelity Funds ASEAN Fund
- Fidelity Funds Euro Cash Fund
- Fidelity Funds European Growth Fund
- Fidelity Funds Germany Fund
- Fidelity Funds Global Bond Fund
- Fidelity Funds Global Technology Fund
- Fidelity Funds India Focus Fund
- Fidelity Funds Nordic Fund
- Fidelity Funds Pacific Fund
- Fidelity Funds Thailand Fund
- Fidelity Funds US Dollar Bond Fund
- Fidelity Funds US Dollar Cash Fund
- Fidelity Funds World Fund

Furthermore, the current investment process of the above Underlying Funds (save for, Fidelity Funds - Euro Cash Fund and Fidelity Funds - US Dollar Cash Fund) provide that they invest at least 50% of their assets in securities of issuers or companies with favourable ESG characteristics and the current investment process of Fidelity Funds - Euro Cash Fund and Fidelity Funds - US Dollar Cash Fund provide that these Underlying Funds invest at least 70% of their assets in securities of issuers with favourable ESG characteristics and up to 30% in securities of issuers with [low but] improving ESG characteristics. These limits will no longer be included as part of the investment process of the Underlying Funds.

II. Increasing the minimum commitment to specific ESG criteria for multi-asset Underlying Funds

The following Underlying Funds will align investment of at least 70% of their respective portfolios with specific ESG criteria used by Fidelity for its multi-asset funds, details of which may be viewed at https://fidelityinternational.com/sustainable-investing-framework/1.

- Fidelity Funds European Multi Asset Income Fund
- Fidelity Funds Global Thematic Opportunities Fund

III. Updates to minimum ESG characteristics commitment of Fidelity Funds - China Focus Fund

They will be removing the Fidelity Funds - China Focus Fund's minimum commitment to invest at least 50% of assets in securities with favourable ESG characteristics and the Investment Manager will take into account Sustainability Risks in its investment process. Consequently, the Fidelity Funds - China Focus Fund will no longer be categorized as an Article 8 product under the Sustainable Finance Disclosure Regulation ("SFDR").

IV. Change in benchmark for Fidelity Funds - Nordic Fund

They will be changing the benchmark of Fidelity Funds - Nordic Fund used for performance comparison purposes from FTSE Nordic 30 Index to FTSE Nordic Capped 10% Index. The broader market index (i.e. FTSE Nordic Capped 10% Index) more closely reflects the diversified strategy of the fund and is a more appropriate index for performance comparison. This update does not impact the investment objective or policy of the Underlying Fund.

The above-mentioned changes and other miscellaneous updates and clarifications will be reflected in the next update to the Hong Kong Offering Documents.

What does this mean to you?

If you wish to continue to invest in the Investment Choice(s) after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice(s), you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

富達已通知我們有關影響富達該等相關基金的發展。作為持續履行對負責任及可持續發展投資的承諾的一部分, 富達的可持續發展投資和環境、社會和管治(「**ESG**」)整合方法將會作出更新,以反映不斷演變的可持續發展 投資格局,並提高對投資者的透明度。

由2024年7月30日起,香港發行文件及該等相關基金將會作出以下更新。

I. 為環境、社會和管治(ESG)投資組合加入評分

富達將為若干該等相關基金加入ESG投資組合評分以推動環境和社會特徵。

III. 富達基金 - 中國焦點基金ESG特徵最低承諾的更新

富達將會從投資流程中移除富達基金 - 中國焦點基金把最少50%的資產投資於具有有利ESG特徵之證券 · 而投資經理的投資流程將會考慮可持續發展風險的最低承諾 · 因此 · 富達基金 - 中國焦點基金將不再被歸類為《可持續發展披露框架條例》(「SFDR」)第8條產品 ·

IV. 富達基金 - 北歐基金的基準變動

富達將把富達基金 - 北歐基金用作表現比較的基準由FTSE Nordic 30指數更改為FTSE Nordic Capped 10%指數。 大盤指數(即FTSE Nordic Capped 10%指數)更能反映基金的多元化策略,為更適合用作表現比較的指數。本次 更新不會影響該相關基金的投資目標或政策。

香港發行文件將於下一次更新時反映上述變動以及其他更新和說明。
