What is happening?

We have been notified by the Board of Directors of Invesco of the changes to the Underlying Fund as further described below, to be included in the Prospectus dated July 15, 2024 (the "Effective Date").

All costs associated with the proposed below changes will be borne by the Management Company.



Reduction of the management fee of the Underlying Fund

From the Effective Date, the management fee (expressed as a percentage per annum of the average NAV of the class of share) of the Underlying Fund will be reduced as follows:
