What is happening?

We have been notified by the board of directors of Morgan Stanley Investment Funds that the Underlying Funds shall not accept any subscription and switching-in anymore.

What does this mean to you?

As a result of the above, you will not be allowed to invest into the Investment Choices by way of new instruction for subscription, redirecting future regular premium allocation, top-up premium and switching-in from the date of this notice.

If you originally allocate future regular premiums into the Investment Choice(s), we will redirect your future regular premium allocation from the Investment Choice(s) into the Default Investment Choice(s), free of charge, with immediate effect.

If you do not agree with our decision to redirect your future regular premium allocation from the Investment Choice(s) to the Default Investment Choice(s), you may redirect your future regular premiums allocation and/ or switch your holding of notional units from the Default Investment Choice(s) to other investment choice(s) available under the respective Schemes, free of charge, by submitting an instruction to us at any-time.
