What is happening?

We have been notified by First Sentier of the various changes to First Sentier and the Underlying Funds. They are making certain changes and updates in their revised Prospectus which is expected to be published on or around November 28, 2024 (the "**Effective Date**"). These updates are summarized below.

A. Clarification of Sustainable Finance Disclosure Regulation ("SFDR") disclosures of the Underlying Funds set out in Appendix 1 (the "Article 8 Underlying Funds")

SFDR entered into force in the European Union on March 10, 2021 with aim of harmonising transparency with regards to the integration of sustainability risks and consideration of adverse sustainability impacts, and the provision of sustainability-related information. On April 6, 2022, the European Commission adopted a regulation supplementing the SFDR specifying further details regarding the presentation of information in fund prospectuses ("SFDR Level 2 rules").

To provide greater clarity in respect of SFDR Level 2 rules, First Sentier will further revise their Prospectus disclosures with respect to the Article 8 Underlying Funds. These revisions are intended to enhance and better clarify the process that First Sentier follows for the Article 8 Underlying Funds as described in Appendix 9 of their revised Prospectus. In particular, First Sentier will enhance and clarify the disclosures on the promoted environmental and/or social characteristics, sustainability indicators (and the methods of assessment), the principal adverse impacts on sustainability factors and positive environmental and social outcomes assessed by the Investment Manager.

As confirmed by First Sentier, notwithstanding the amendments, there are no material changes to the sustainability objectives, or environmental or social characteristics promoted by each of the Underlying Funds. There will be no change to the way the Article 8 Underlying Funds are currently being managed as a result of such updates.

B. Update to the fund name of First Sentier Investors Global Umbrella Fund plc - Stewart Investors Worldwide Leaders Sustainability Fund (managed by the Sustainability Funds Group)

Historically, Stewart Investors comprised of two distinctly branded sub-investment teams - the Sustainability Funds Group and St Andrews Partners.

First Sentier has historically included reference to the term "Sustainability" in the name of certain funds managed by the Sustainability Funds Group with the aim of distinguishing these from the funds managed by St Andrews Partners. Following the closure of St Andrews Partners in 2022, the need to distinguish these funds by reference to "Sustainability" is no longer required.

Accordingly, the proposed change to the fund name of the Underlying Fund is as follows:

a. Removing the word "Sustainability" from the Underlying Fund name

Notwithstanding such change, the Stewart Investors investment team's process remains unchanged; the team
will continue to invest over the long-term and continue to focus on both a company's sustainability impact, and
its quality of management, franchise and finances.

As confirmed by First Sentier, save for the name change of the Underlying Fund, the existing investment objective and policy (in particular, the key investment focus in sustainability and the current sustainability investment strategy) of the Underlying Fund remain unchanged and no change will be made to the way the Underlying Fund is currently being managed.

C. Updates applicable to First Sentier Investors Global Umbrella Fund plc - First Sentier Asian Quality Bond Fund

The Underlying Fund will be re-positioned from a SFDR Article 6 Fund to a SFDR Article 8 Fund.

First Sentier will enhance and clarify the investment policy of the Underlying Fund to reflect that:

- the Underlying Fund will not invest in companies/issuers that derive any revenue directly from the manufacture
 of controversial weapons or tobacco products or that own more than a 50% interest in entities that derive any
 revenue directly from the manufacture of controversial weapons or tobacco products;
- the Underlying Fund does not abstain from investing in fossil fuel companies (including oil, gas, thermal, metallurgical coal mining and power generation, as well as fossil fuel related infrastructure and services); and
- the Investment Manager's analysis considers a variety of risk dimensions, including an emphasis on ESG factors that can have an important influence on companies' ability to service their debt obligations over the long term. ESG analysis is undertaken as part of the Fund's credit research process for all the issuers and each issuer is assigned with a risk category (high, moderate, low) based on the team's ESG assessment.

In addition, in line with SFDR Article 8 requirements First Sentier will also include a new annex in Appendix 9 of their revised Prospectus to explain the Underlying Fund's:

- · sustainability assessments;
- environmental and social characteristics assessed;
- · exclusion policy; and
- engagement policy.

D. Clarification of investment policy of First Sentier Investors Global Umbrella Fund plc - First Sentier Global Listed Infrastructure Fund

First Sentier will update the investment policy of the Underlying Fund to clarify that the infrastructure sector includes operating assets from the transport, utilities, energy and communication sectors.

As confirmed by First Sentier, the above change is merely enhancement and for clarification purposes. There will be no change in the way the Underlying Fund is currently being managed.

E. Update on soft dollar policy

First Sentier will update their Prospectus to reflect that, neither the Manager, the Investment Managers, the Sub-Investment Manager(s) nor any of their respective subsidiaries, affiliates, group members, associates, agents, directors, officers or delegates will receive goods or services (soft dollar) or cash rebates from a broker or dealer in relation to the management of First Sentier's assets other than permissible, minor non-monetary benefits.

F. Updates to the list of Regulated Markets under "APPENDIX 5 - REGULATED MARKETS"

First Sentier will update the list of Regulated Markets contained in Appendix 5 of their Prospectus.

G. Updates to the list of sub-custodians under "APPENDIX 8 - DELEGATES OF THE DEPOSITARY"

First Sentier will update the list of the sub-custodians appointed by the Depositary. This list can be found in Appendix 8 of the Prospectus of First Sentier. The list will be updated to the Effective Date.



H. Other miscellaneous, taxation, enhancement, clarificatory, administrative, general regulatory and cosmetic updates to First Sentier's Prospectus, including enhancement of risk disclosures on currency hedging and clarification on the income equalisation mechanism in respect of distribution for Distributing Class Shares.

As confirmed by First Sentier, in respect of the above changes:

- there will be no other change in the operation and/or manner in which the Underlying Funds are being managed;
- save as otherwise disclosed above, there are no other effects on existing investors in the Underlying Funds
 as a result of the changes; there will be no change to the features and the risk applicable to the Underlying
 Funds; and there will be no change to the level of fees or costs in managing the Underlying Funds; and
- the changes will not result in any impact that might materially prejudice the rights or interests of existing investors in the Underlying Funds.

Unless otherwise specified above, the above changes will take effect on or around the Effective Date.

First Sentier will issue an updated Prospectus to reflect the changes described in this letter.

Additionally, in Hong Kong, the Hong Kong Supplement and the product key facts statements ("KFS") of the Underlying Funds authorised by the SFC will be updated accordingly.

The updated Prospectus of First Sentier, any impacted local prospectus supplement (including the Hong Kong Supplement and the KFS of the Underlying Funds authorised by the SFC) will be available on or around the Effective Date and on the following website:www.firstsentierinvestors.com¹.

What does this mean to you?

In view of the changes to the name of First Sentier Investors Global Umbrella Fund plc - Stewart Investors Worldwide Leaders Sustainability Fund described above, the name of the corresponding Investment Choice will also be updated from the Effective Date per below:

修訂事項

首源已通知我們有關對首源及該等相關基金作出的多項變更。首源正在編製其預期將於2024年 11月28日(「生效日期」)或前後刊發的經修訂基金章程內的若干變更及更新資料。該等更新 資料概述如下。

A. 澄清附錄一所載該等相關基金(「第8條該等相關基金」)的可持續金融披露條例 (「SFDR」)披露資料

於2021年3月10日·SFDR在歐洲聯盟生效·旨在協調在整合可持續發展風險與考慮不利可持續發展影響方面的透明度·並提供可持續發展相關資料。於2022年4月6日·歐盟委員會採納一項補充SFDR的規例·列明有關於基金章程中呈列資料的進一步詳情(「SFDR第2級規則」)。



為了就SFDR第2級規則作出更清晰的說明,首源將進一步修訂基金章程中有關第8條該等相關基金的披露資料。該 等修訂旨在優化及更清晰說明首源就第8條該等相關基金所遵循的流程,詳情載於經修訂基金章程附錄九。尤其 是,首源將優化及澄清有關以下各項的披露資料:所提倡的環境及/或社會特徵、可持續發展指標(及評估方 法)、對可持續發展因素的主要不利影響及投資經理評估的正面環境及社會成果。

首源已確認,儘管有該等修訂,但該等相關基金各自所提倡的可持續發展目標或環境或社會特徵並無重大變更。 第8條該等相關基金的現有管理方式不會因該等更新而出現變更。

B. 更新首源投資環球傘子基金有限公司 - 盈信世界領先可持續發展基金的基金(由可持續發展基金小組管理)名稱

以往·盈信由兩個不同品牌的子投資團隊組成·即可持續發展基金小組(Sustainable Funds Group)及St Andrews Partners。

首源曾經在可持續發展基金小組管理的若干基金的名稱中加入「可持續發展」一詞,旨在將此等基金與St Andrews Partners管理的基金作出區分。隨著St Andrews Partners於2022年結束,首源不再需要「可持續發展」一詞以區分該等基金。

因此,首源建議對該相關基金的基金名稱作出如下變更:

a. 移除該相關基金名稱中的「可持續發展」字眼

儘管有上述變更,但盈信投資團隊的流程維持不變;團隊將繼續進行長線投資,並繼續著重公司的可持續發展 影響及其管理、特許經營業務及財務質素。

首源已確認·除該相關基金的名稱變更外·該相關基金的現有投資目標及政策(尤其是將可持續發展作為主要投資重點及現行可持續發展投資策略)維持不變·且該相關基金的現有管理方式不會出現變更。

C. 首源投資環球傘子基金有限公司 - 首源亞洲優質債券基金適用的更新資料

該相關基金將由SFDR第6條基金重新定位為SFDR第8條基金。

首源將優化並澄清該相關基金的投資政策,以反映:

- 該相關基金不會投資於直接從製造爭議性武器或煙草製品而獲得任何收入的公司/發行人·亦不會投資於在直接從製造爭議性武器或煙草製品而獲得任何收入的實體中擁有超過50%權益的公司/發行人;
- 該相關基金不迴避投資於化石燃料公司(包括石油、天然氣、熱能、冶金煤開採及發電以及與化石燃料相關的基礎設施及服務);及
- 投資經理的分析考慮多個風險維度,包括重視會對公司長期償債能力產生重要影響的ESG因素。ESG分析是基金對所有發行人進行信貸研究流程的一環,並根據該團隊的ESG評估為每間發行人評定風險類別(高、中、低)。

此外·根據SFDR第8條的要求·首源亦會在其經修訂基金章程附錄九中加入新附件·以解釋該相關基金的:

- 可持續性評估;
- 評估的環境及社會特徵;
- 排除政策;及
- 參與政策。

D. 澄清首源投資環球傘子基金有限公司 - 首源全球基建基金的投資政策

首源將更新該相關基金的投資政策,以澄清基建板塊包括交通、公用事業、能源及通訊板塊的營運資產。

首源已確認,上述變更僅用作優化及澄清用途。該相關基金的現有管理方式不會出現變更。



E. 有關非金錢利益政策的更新

首源將更新其基金章程,以反映基金經理、投資經理、副投資經理或彼等各自的任何附屬機構、聯屬公司、集團成員公司、聯繫人士、代理、董事、高級職員或獲轉授職能者均不會從與首源資產管理有關的經紀或交易商收取商品或服務(非金錢利益)或現金回扣,獲許可的小額非金錢利益則不在此限。

F. 更新「附錄五 - 受監管市場」項下的受監管市場名單

首源將更新其基金章程附錄五所載的受監管市場名單。

G. 更新「附錄八-保管人獲轉授職能者」項下副託管人的名單

首源將更新保管人委任的副託管人名單。此名單載於首源基金章程附錄八。名單將更新至生效日期。

H. 首源基金章程的其他雜項、稅務、加強、澄清、行政、一般監管及改進的更新資料,包括加強貨幣對沖的風險 披露及澄清與派息類別股份分派相關的收益平衡機制。

首源已確認,就上述變更而言:

- 該等相關基金的營運及/或管理方式將不會出現其他變更
- 除上文所披露者外·上述變更並無對該等相關基金的現有投資者造成其他影響;該等相關基金適用的特點及風險不會變更;且管理該等相關基金的費用或成本水平不會變更;及
- 該等變更概不會產生可能對該等相關基金現有投資者權利或權益造成嚴重損害的任何影響。
