#### What is happening?

We have been notified by Director of JPMorgan Funds (Asia) Limited (the "Manager") about certain change to the Underlying Fund as stated below.

## Removal of JPMorgan Asset Management (Singapore) Limited as Sub-Manager of the Underlying Fund

Currently, JPMorgan Asset Management (Singapore) Limited is the Sub-Manager of the Underlying Fund.

Due to reallocation of resources, from November 29, 2024, JPMorgan Asset Management (Singapore) Limited will be removed as the Sub-Manager of the Underlying Fund.

As confirmed by the Manager, save as disclosed above, there will be no change in the operation and/or manner in which the Underlying Fund is being managed. The above change will have no impact on the investment objective, features and the overall risk profile of the Underlying Fund or the fee level/cost in managing the Underlying Fund. The Manager of the Underlying Fund is of the opinion that the above changes will not materially prejudice the interests of existing investors of the Underlying Fund.

The legal and other administrative costs associated with the change above, estimated to be approximately USD5,000, will be borne by the Underlying Fund and other relevant funds under JPMorgan Funds (Unit Trust Range) equally.

Other miscellaneous amendments have been made in the offering documents of the Underlying Fund.

The offering documents of the Underlying Fund, which have been revised to reflect the above updates, are available free of charge on the Manager's website am.jpmorgan.com/hk<sup>1</sup>.

#### What does this mean to you?

If you wish to continue to invest in the Investment Choice(s) after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice(s), you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.
