We are writing to let you know about the changes to the Underlying Fund. You have invested in at least one of the investment choices corresponding to the Underlying Fund, which are listed in the "Which investment choices are affected?" table below under the column "Name and code of the investment choice".

What is happening?

We have been notified by Franklin Templeton Investments (Asia) Limited, as the Hong Kong representative of FTIF (the "Hong Kong Representative"), of the following changes, which will become effective as from October 10, 2025 (the "Effective Date").

The board of directors of FTIF (the "**Board**") has decided to rename the Underlying Fund to "Franklin Templeton Investment Funds - Franklin Global Income and Growth Opportunities Fund".

Accordingly, all references to "Franklin Templeton Investment Funds - Franklin Global Income Fund" in the Hong Kong offering documents of FTIF will be updated to reflect the Underlying Fund's new name.

Why is FTIF making this change?

The Underlying Fund's new name more accurately reflects the income and capital appreciation characteristics of the Underlying Fund's investment objective and policy.

As confirmed by the Hong Kong Representative, the above changes will have no impact on the features and risks applicable to the Underlying Fund. The above changes will also have no impact on the operation and/or manner in which the Underlying Fund is being managed and there will be no effect on investors. In addition, there will be no change in the fee level or cost in managing the Underlying Fund following the implementation of the above changes. It is not expected that the above changes will materially prejudice the rights or interests of investors.

The Explanatory Memorandum and the product key facts statement of the Underlying Fund will be updated to reflect the above changes in due course. An updated version of the Hong Kong offering documents of FTIF will be available for download from the Hong Kong Representative's website at www.franklintempleton.com.hk¹.

What does this mean to you?

In view of the change of name of the Underlying Fund as described above, the name of the corresponding Investment Choices will also be updated from the Effective Date per below:

However, if you do not wish to maintain your investment in the Investment Choice(s), you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.
