Changes to Franklin Templeton Investment Funds - Templeton BRIC Fund (the “Underlying Fund”)

Dear valued customer,

We are writing to let you know about the changes to the Underlying Fund. You have invested in the investment choice corresponding to the Underlying Fund, which is listed in the “Which investment choice is affected?” table below under the column “Name and code of the investment choice”.

What is happening?

We have been notified by Franklin Templeton Investments (Asia) Limited, as the Hong Kong representative of FTIF (the “Hong Kong Representative”), of the following changes, which will become effective as from December 9, 2025 (the “**Effective Date**”).

Removal of the references to Russia in the investment policy, name and benchmark of the Underlying Fund

The board of directors of FTIF (the “**Board**”) has decided, in light of the current geopolitical situation in Russia, to rename the Underlying Fund to “Franklin Templeton Investment Funds - Templeton BIC Fund” and to remove the references of Russia from the Underlying Fund’s investment policy, name and benchmark. These changes are made solely for clarification purposes and to reflect the Underlying Fund’s current portfolio composition, as the Underlying Fund is restricted from investing in Russian securities due to international economic sanctions.

Accordingly, the following changes shall be made to the Explanatory Memorandum:

- (i) The name of the Underlying Fund will be changed to “Franklin Templeton Investment Funds - Templeton BIC Fund”. All references to the Underlying Fund will be amended to reflect the new name of the Underlying Fund.
- (ii) The first paragraph under the sub-section headed “Investment Policy” in the Underlying Fund’s profile will be amended as follows (with revisions shown in mark-up):

“The Fund invests primarily in equity securities of companies (i) organised under the laws of or with their principal office in Brazil, ~~Russia~~, India and China (including Hong-Kong and Taiwan) (“BRIC”) or (ii) which derive the principal portion of their revenues or profits from BRIC economies or have the principal portion of their assets in BRIC economies.”

- (iii) The sub-section headed “Investor’s Profile” in the Underlying Fund’s profile will be amended as follows (with revisions shown in mark-up):

“Considering the investment objectives, as stated above, the Fund may appeal to investors looking to:~~The Fund is suitable for investors:~~

- *achieve ~~seeking~~ capital appreciation by investing in securities of companies in Brazil, ~~Russia~~, India and China, including Hong Kong and Taiwan; and*
- *planning to hold their investments for the~~invest~~ for the medium to long term.”*

- (iv) “Russian and Eastern European Markets risk” will be removed from the sub-section headed “Risks of Investing in the Fund” in the Underlying Fund’s profile as a risk pertaining to the Underlying Fund.
- (v) The benchmark of the Underlying Fund as disclosed under the section headed “BENCHMARK DISCLOSURE” will be changed from “MSCI BRIC Index” to “MSCI BIC Index”.

As confirmed by the Hong Kong Representative, the above changes will have no material impact on the features and risks applicable to the Underlying Fund. They will also have no material impact on the operation and/or manner in which the Underlying Fund is being managed, and there will be no effect on investors. There will be no change in the fee level or cost in managing the Underlying Fund following the implementation of the above changes. It is not expected that the above changes will materially prejudice the rights or interests of investors.

The costs and/or expenses associated with the above changes are estimated to be approximately HKD 285,000 and will be borne by the Underlying Fund.

The Explanatory Memorandum and the product key facts statement of the Underlying Fund will be updated to reflect the above changes in due course. An updated version of the Hong Kong offering documents of FTIF will be available for download from the Hong Kong Representative’s website at www.franklintempleton.com.hk¹.

What does this mean to you?

In view of the change of name of the Underlying Fund as described above, the name of the corresponding Investment Choice will also be updated from the Effective Date per below:

However, if you do not wish to maintain your investment in the Investment Choice, you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

修訂事項

FTIF的香港代表富蘭克林鄧普頓投資（亞洲）有限公司（「該香港代表」）已通知我們以下變更。相關變更將於2025年12月9日（「生效日期」）生效。

刪除該相關基金的投資政策、名稱及基準中有關俄羅斯的提述

有鑑於俄羅斯目前的地緣政治情況，FTIF的董事會（「該董事會」）已決定將該相關基金更名為「富蘭克林鄧普頓投資基金 - 鄧普頓新興三國（巴西、印度及中國）基金」，以刪除該相關基金的投資政策、名稱及基準中有關俄羅斯的提述。上述變更純屬釐清用途，並旨在反映該相關基金目前的投資組合構成，因該相關基金因應國際經濟制裁而被限制不得投資於俄羅斯證券。

因此，將對該基金說明書作出以下更改：

- 該相關基金的名稱將更改為「富蘭克林鄧普頓投資基金 - 鄧普頓新興三國（巴西、印度及中國）基金」。所有對該相關基金的提述均將予以修訂，以反映該相關基金的新名稱。
- 該相關基金的概況中標題為「投資政策」一分節的第一段將修訂如下（修訂已標明）：

「本基金主要投資於 (i) 根據巴西、~~俄羅斯~~印度及中國（包括香港及台灣）（「新興四強三國（巴西、印度及中國）」）法例成立或於上述地區設有主要辦事處的公司或 (ii) 其大部份收入或溢利均來自新興四強三國（巴西、印度及中國）的經濟或其大部份資產均在新興四強三國（巴西、印度及中國）的經濟。」

- 該相關基金的概況中標題為「投資者的概況」一分節將作如下修訂（修訂已標明）：

「考慮到上述投資目標，本基金可能吸引尋求以下目標的投資者：本基金適合以下投資者：

- 透過投資於在巴西、~~俄羅斯~~印度及中國（包括台灣及香港）的公司的股票以謀求實現資本增值；及
- 計劃以此作為中線至長線持有投資。」

- (iv) 「俄羅斯及東歐市場風險」將從該相關基金的概況中標題為「投資於本基金的風險」一分節中刪除，不再作為與該相關基金相關的風險。
- (v) 標題為「基準披露」一節中披露的該相關基金的基準將由「摩根士丹利金磚四國指數」更改為「摩根士丹利三國（巴西、印度及中國）指數」。

該香港代表已確認，上述變更不會對適用於該相關基金的特徵及風險產生任何影響。上述變更亦不會影響該相關基金的運作及／或管理方式，並且不會對投資者造成任何影響。此外，在實施上述變更後，該相關基金的管理費用或成本將不會有所變動。預期上述變更不會對投資者的權益或利益造成重大損害。

與上述變更相關的成本及／或開支預計約為港幣 285,000，並將由該相關基金承擔。

該基金說明書及該相關基金的產品資料概要將適時更新，以反映上述變更。FTIF香港發售文件的更新版本可於香港代表網站 www.franklintempleton.com.hk¹ 下載。
