We are writing to let you know about the changes to the Underlying Funds. ## What is happening?

We have been notified by the FTGF that its directors have decided to approve certain amendments to the Underlying Funds. Details of some of the more significant amendments being made to the Underlying Funds are set out in the table below.



Underlying Funds	Change	Rationale
Franklin Templeton Global Funds plc - FTGF Brandywine Global Fixed Income Fund	To reduce the annual management charge ("AMC") of the following share class of the Underlying Fund:  Class A: From 1.10% to 0.85%  These AMC changes were implemented on June 20, 2025.	This revised fee structure supports asset growth and offers enhanced value aligned with the Underlying Fund's objective and investment policy.
Franklin Templeton Global Funds plc - FTGF ClearBridge US Value Fund	To add the following exclusion, which is listed as a binding element of the investment strategy of Underlying Fund: "companies that generate more than 30% of their revenues from coalbased power generation, or the mining or distribution of thermal coal or metallurgical coal."	This update formalises the Underlying Fund's commitment to exclude from its investment universe companies that generate more than 30% of revenue from coal-based power generation, or the mining or distribution of thermal coal or metallurgical coal. This will not change how the Underlying Fund is managed.
	To update the investment policy to increase the minimum percentage of the Underlying Fund's net asset value that will be invested in equity securities from 51% to 70%.	The Underlying Fund has historically invested over 70% of its net asset value in equities, so this update is a clarificatory change that will not impact how the Underlying Fund is managed.

The amendments to the Prospectus and the supplements of the Underlying Funds will take effect on the date on which the revised Prospectus and the revised supplements of the Underlying Funds are approved by the Central Bank of Ireland (the "**Effective Date**"). The Effective Date will be on or around October 31, 2025. The Hong Kong offering documents of the Underlying Funds will be updated to reflect the changes as set out herein, as well as other miscellaneous updates, drafting and/or editorial amendments, on or after the Effective Date.

#### What does this mean to you?

If you wish to continue to invest in the Investment Choice(s) after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice(s), you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.
