What is happening?

We have been notified by the board of directors of HSBC Global Investment Funds ("**HGIF**") (the "**Board**") of a change in reference benchmark to the Underlying Fund. The change will take effect on October 31, 2025 and will be reflected in the next prospectus of HGIF, which is expected to be published in December 2025.

Reason for the Change

This reference benchmark has been chosen as it brings greater diversification of companies and therefore more closely aligns to the investment objective and strategy of the Underlying Fund.

Impact on Investors

As confirmed by the Board, there will be no change in the Underlying Fund's investment objective, strategy or the overall risk profile of the Underlying Fund.



The Hong Kong offering documents of HGIF and product key facts statement of the Underlying Fund will be amended to reflect the change set out above in due course.

What does this mean to you?

If you wish to continue to invest in the Investment Choice after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice, you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s).
