What is happening?

We have been notified by NBIF of proposed changes to NBIF and to certain Underlying Funds, which will be reflected in the revised Hong Kong Offering Documents. Unless otherwise stated in this letter, subject to the approval of the Central Bank of Ireland, it is expected that these updates will be effective on or around November 27, 2025.

The directors of NBIF have decided to update the Hong Kong Offering Documents as further outlined below (the "Fund Document Updates").

1. Supplement Updates

1.1. Supplement updates applicable to Neuberger Berman Investment Funds plc - Neuberger Berman Emerging Market Debt - Hard Currency Fund

Amendments have been made to the "Investment Approach" and "Instruments/Asset Classes" sections to clarify that the scope of emerging market countries also include countries which are part of the Underlying Fund' benchmark, with effect from July 1, 2025.

As confirmed by NBIF, the above changes do not have a material impact on the existing holdings or investment strategies of the Underlying Fund.

2. Miscellaneous Hong Kong Offering Documents Updates

In addition, a number of additional minor amendments will also be made to the Hong Kong Offering Documents, including but not limited to, updates for clarity, updates for consistency of terminology, inclusion of additional definitions, updates to reflect passage of time changes and other miscellaneous non-material updates.

3. Effect of Updates

As confirmed by NBIF, the Fund Document Updates will not (a) have a material impact on (i) the investment objectives and policies of the Underlying Funds; (ii) the manner in which the Underlying Funds are being operated and managed; and (iii) the features and overall risk profiles of the Underlying Funds; and (b) increase the level of fees payable by the Underlying Funds and the investors, or materially change the fee level / cost in managing the Underlying Funds. It is also not expected that the investors will be materially affected or prejudiced as a result of the above changes.

The costs incurred in relation to the changes discussed above will be borne by each relevant Underlying Fund.

The Fund Document Updates will be reflected in updated versions of the Hong Kong Offering Documents, which will be available on the website of NBIF's Hong Kong representative at www.nb.com (Hong Kong investors should note that this website has not been reviewed by the SFC and may contain information on funds not authorised by the SFC).

What does this mean to you?

If you wish to continue to invest in the Investment Choice(s) after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice(s), you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

修訂事項

NBIF已通知我們對NBIF及若干該等相關基金作出的建議更改,有關更改將於經修訂的該等香港 銷售文件中反映。除非本函件另有述明及經愛爾蘭中央銀行批准,否則該等更新將於2025年11 月27日或前後生效。

NBIF的董事會已決定更新該等香港銷售文件(「該等基金文件更新」),進一步概述如下。

1. 補充文件的更新

1.1. 適用於路博邁投資基金 - NB新興市場債券基金 - 強勢貨幣的補充文件更新

「投資方法」及「工具/資產類別」各節已作出修訂‧以澄清由2025年7月1日起‧新興市場國家的範疇亦包括作為該相關基金的基準指數的一部分的國家。

NBIF已確認,上述更改不會對該相關基金的現有持股或投資策略產生重大影響。

2. 該等香港銷售文件的雜項更新

此外·亦將對該等香港銷售文件作出多項新增而輕微的修改·包括但不限於為作出澄清性的更新、為術語一致性的更新、載入新增的定義、反映隨時間轉變的更新及其他雜項而不重要的更新。



3. 更新的影響

上文所述對該等香港銷售文件作出的建議更新 (a)不會對(i)該等相關基金的投資目標及政策;(ii)該等相關基金的營運及管理方式;及(iii)該等相關基金的特點及整體風險狀況造成重大影響;及(b)不會提高該等相關基金及投資者應付的費用水平·或對管理該等相關基金的費用水平及/或成本造成重大變更。同時亦預期投資者不會因上述更改而受到重大影響或損害。

最後,因上文所論述的更改而招致的成本將由該等相關基金各自承擔。

該等基金文件更新將反映於已更新版本的該等香港銷售文件,已更新版本的該等香港銷售文件將可在NBIF的香港代表的網站www.nb.com瀏覽(香港投資者應注意,此網站並未經證監會審閱,並可能載有未經證監會認可的基金的資料)。
