What is happening to the Underlying Funds?

We have been notified by the board of directors of BNP (the “**Board**”) of the following changes to the Underlying Funds that will be incorporated in the next version of the Hong Kong offering document of BNP (the “**Hong Kong Offering Document**”).

Replacement of investment manager

Following the acquisition of AXA Investment Managers by BNP Paribas, the local integration of this acquisition in the United States is expected to be implemented by a sale of assets (including investment management delegation agreements) from BNP Paribas Asset Management USA, Inc. (“**BNPP AM USA**”) to AXA Investment Managers US, Inc. (“**AXA IM US**”).

From July 1, 2026, AXA IM US will replace BNPP AM USA. As a second step, from November 30, 2026, AXA IM US will be renamed BNP PARIBAS Asset Management United States, Inc..

As confirmed by the Board, there will be no impact on (i) the way the Underlying Funds will be managed or (ii) on the fee structure of the relevant Underlying Funds.

Change of denominations of investment manager

Following the acquisition of AXA Investment Managers by BNP Paribas and the local integration of this acquisition in the United Kingdom, AXA Investment Managers UK Limited (“**AXA IM UK**”) will be renamed as from November 30, 2026, BNP PARIBAS ASSET MANAGEMENT (UK) Limited.

As confirmed by the Board, there will be no impact on (i) the way the Underlying Funds will be managed or (ii) on the fee structure of the relevant Underlying Funds.

Removal of Alfred Berg Kapitalforvaltning AS

BNP adopted a “pool approach” whereby the management company has delegated its discretionary investment management functions in respect of each of the Underlying Funds of BNP to one or more investment managers. Due to corporate restructuring within entities of BNP Paribas group, Alfred Berg Kapitalforvaltning AS will no longer act as the investment manager for SFC-authorized¹ Underlying Funds of BNP with immediate effect.

Details of the relevant portfolio manager(s) responsible for a particular Underlying Fund will be listed in the annual report of BNP and will be available for inspection free of charge at 17/F Lincoln House, Taikoo Place, 979 King’s Road, Quarry Bay, Hong Kong, during normal business hours on any Hong Kong business day.

As confirmed by the Board, changes above will not result in any increment in fees level or costs in managing the Underlying Funds. In addition, no costs or expenses will be incurred in connection with the changes. The changes would not materially change the features and overall risk profile of the Underlying Funds. There would be no change in the operations or the manner in which the Underlying Funds are being managed. Further, the changes would not materially prejudice the existing investors’ rights of interest.

The Hong Kong Offering Document will be updated to reflect the change above. The current Hong Kong Offering Document is available on the website at <https://www.bnpparibas-am.com/en-hk>². The updated Hong Kong Offering Document will be available later.

該等相關基金修訂事項

法巴的董事會（「該董事會」）已通知我們，以下對該等相關基金作出的變動將會納入法巴下一版本的香港銷售文件（「該香港銷售文件」）。

更換投資經理

法國巴黎銀行收購安盛投資管理後，於美國就是次收購進行的地區業務整合預計將透過 BNP Paribas Asset Management USA, Inc.（「BNPP AM USA」）向 AXA Investment Managers US, Inc.（「AXA IM US」）出售資產的方式進行（包括投資管理職能轉授協議）。

由2026年7月1日起，AXA IM US將取代BNPP AM USA。隨後，由2026年11月30日起，AXA IM US將更名為BNP PARIBAS Asset Management United States, Inc.。

該董事會已確認，上述變動將不會對 (i) 該等相關基金的管理方式或 (ii) 該等相關基金的費用結構造成任何影響。

投資經理名稱的變更

在法國巴黎銀行收購安盛投資管理，並於英國就是次收購進行地區業務整合後，AXA Investment Managers UK Limited（「AXA IM UK」）將於2026年11月30日起更名為BNP PARIBAS ASSET MANAGEMENT (UK) Limited。

該董事會已確認，上述變動將不會對 (i) 該等相關基金的管理方式或 (ii) 該等相關基金的費用結構造成任何影響。

免除Alfred Berg Kapitalforvaltning AS

法巴採取「匯集策略」，據此，管理公司已就每項法巴的該等相關基金轉授其全權委託投資管理職能予一名或多名投資經理。鑑於法國巴黎銀行集團的實體進行企業重組，因此自即日起，Alfred Berg Kapitalforvaltning AS 將不再擔任證監會認可的法巴該等相關基金¹的投資經理。

負責某一該相關基金的有關投資組合經理的詳情將列載於法巴年度報告內，並可於任何香港營業日正常辦公時間內在香港鰂魚涌英皇道979號太古坊林肯大廈17樓供免費查閱。

該董事會已確認，上述變動將不會導致管理該等相關基金的費用水平或成本增加。此外，變動不會招致任何成本或開支。變動不會顯著改變該等相關基金的特點及整體風險範圍。該等相關基金的運作或管理方式並無改變，亦不會顯著損害現有投資者的權利或權益。
