We are writing to let you know about the changes to Schroder and the Underlying Funds. What is happening to the Underlying Funds?

We have been notified by Schroder of the following changes or updates to the Hong Kong offering documents of Schroder and Underlying Funds, comprising the Prospectus and Hong Kong Covering Document of Schroder and the Product Key Facts Statements of the Underlying Funds (the “**Hong Kong Offering Documents**”). Unless otherwise specified, all changes and updates have been made to the Prospectus with effect from July 17, 2026.

I. Updates to liquidity risk management framework

The Prospectus has been updated to provide that:

- (a) at least two appropriate liquidity management tools have been selected for each Underlying Fund, taking into account the Underlying Funds’ investment strategy, liquidity profile and redemption policy. In this context, swing pricing and redemption gates have been selected as the main liquidity management tools for all the Underlying Funds;
- (b) in accordance with applicable laws and regulations, Schroder also has the possibility to implement the following liquidity management tools, which are available for all Underlying Funds, in exceptional circumstances and where justified having regard to the interests of the investors of the concerned Underlying Fund:
 - temporary suspension of subscriptions and redemptions;
 - temporary activation of side pockets;
- (c) Schroder may decide to activate liquidity management tools in normal or stressed market conditions, as it considers appropriate, taking into account the best interests of the investors of the Underlying Funds; and
- (d) together with the management company of Schroder, Schroder Investment Management (Europe) S.A. (the “**Management Company**”), the directors of Schroder have established internal policies and procedures detailing the activation, deactivation and calibration of any selected liquidity management tool and the operational and administrative arrangements for the use of such tool.

II. Miscellaneous updates / changes

Additional changes have been made to the Prospectus, including the following:

- (a) update to reflect the change of address of the registered offices of (a) Schroder and the Management Company with effect from May 26, 2026; and (b) Schroder Investment Management Australia Limited (as the investment manager, sub-investment manager / sub-delegates of certain Underlying Funds) with effect from July 17, 2026;
- (b) updates to reflect changes to the board of directors of the Schroder;
- (c) updates to disclosures on the Benchmark Regulation; and
- (d) other clarifications, miscellaneous updates, changes and editorial amendments.

Save as disclosed above, Schroder confirms that in relation to the amendments or changes set out above:

- there are no changes to how the Underlying Funds are managed;
- the investment style, investment philosophy and risk profile of the Underlying Funds remain the same; and
- the fees chargeable in respect of the Underlying Funds as stated in the Hong Kong Offering Documents remain the same.

The Hong Kong Offering Documents will be updated to reflect the changes set out above and will be available free of charge at www.schroders.com.hk¹.

What does this mean to you?

If you wish to continue to invest in the Investment Choice(s) after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice(s), you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

該等相關基金修訂事項

施羅德已通知我們，以下對施羅德及該等相關基金的香港發售文件（包括該發行章程和香港說明文件及該等相關基金的產品資料概要，合稱為「該等香港發售文件」）作出的更改或更新。除非另有指明，所有對該發行章程作出的更改及更新已自2026年7月17日起生效。

I. 流動性風險管理框架的更新

該發行章程已予更新，以規定以下各項：

- (a) 經考慮該等相關基金的投資策略、流動性狀況及贖回政策，已針對每隻該相關基金選定至少兩項適當的流動性管理工具。就此而言，波動定價及贖回門檻已被選定為所有該等

相關基金的主要流動性管理工具；

- (b) 根據適用的法律及規例，施羅德亦可能在特殊情況及經考慮相關該相關基金投資者利益後認為有充分理由下，對所有該等相關基金實施以下流動性管理工具：
- 暫停認購及贖回；
 - 暫時啟動側袋；
- (c) 在正常或受壓市況下，施羅德可在其視為情況適當及經考慮該等相關基金投資者最佳利益的前提下，決定啟動流動性管理工具；及
- (d) 施羅德的董事已連同施羅德的管理公司Schroder Investment Management (Europe) S.A.（「該管理公司」）制定內部政策及程序，詳述任何選定流動性管理工具的啟動、停用及校準事宜，以及使用有關工具的操作與行政安排。

II. 雜項更新 / 更改

該發行章程亦已作出額外更改，包括以下各項：

- (a) 更新以反映 (a) 施羅德及該管理公司（自2026年5月26日起生效）及 (b) Schroder Investment Management Australia Limited（作為若干該等相關基金的投資經理、副投資經理 / 副委託人）（自2026年7月17日起生效）之註冊辦事處地址的變更；
- (b) 更新以反映有關施羅德董事會的變更；
- (c) 更新有關基準規例的披露；及
- (d) 其他澄清、雜項更新、更改及編輯修訂。

除上文所披露外，施羅德確認，就上文所載的修訂或更改而言：

- 該等相關基金的管理方式並無變更；
- 該等相關基金的投資風格、投資理念及風險概況維持不變；及
- 如該等香港發售文件所述就該等相關基金收取的費用維持不變。

該等香港發售文件將予更新以反映上文所載的更改，並將可於www.schroders.com.hk¹免費查閱。

對您產生的影響

如您在考慮上述變更後仍希望繼續投資於該等投資選擇，則無需就此修訂作出任何行動。倘若您不欲繼續投資於該等投資選擇，可向本公司遞交轉換現有投資或重新指定未來供款分配至其他投資選擇的指示，費用全免。
