We are writing to let you know about the change to the Underlying Fund. You have invested in the investment choice corresponding to the Underlying Fund, which are listed in the "Which investment choices are affected?" table below under the column "Name and code of the investment choice".

What is happening?

We have been notified by Franklin Templeton Investments (Asia) Limited, as the Hong Kong representative of Franklin Templeton Investment Funds ("FTIF"), of the change to the investment management structure of the Underlying Fund which will take effect from December 31, 2023 (the "Effective Date").

Currently, the management company (Franklin Templeton International Services S.à r.l.) (the "Management Company") has delegated the portfolio management of the Underlying Fund to Franklin Templeton Investment Management Limited ("FTIML") as the investment manager and Franklin Templeton Investments Corp. ("FTIC") as well as Templeton Global Advisors Limited ("TGAL") as the submanagers.

To reflect an internal reorganization of investment personnel responsible for the investment management of the Underlying Fund, it is proposed that TGAL will be removed from the investment management structure of the Underlying Fund. Please refer to the following table for a summary of the change:

The investment team at Franklin Templeton has always managed assets based on a team approach and the Underlying Fund will continue to be managed according to the same principles.

The change sets out above will not give rise to any change in the feel level/cost in managing the Underlying Fund. Any costs and/or expenses arising from the above change will be borne by the Management Company, other than the cost of publishing the letter, which is estimated to be approximately HKD 1,000 and which will be charged to the Underlying Fund.

The Explanatory Memorandum of FTIF and the Product Key Facts Statement of the Underlying Fund will be updated to reflect the above change in due course. An updated version of the Explanatory Memorandum of FTIF and the Product Key Facts Statement of the Underlying Fund will be available for download from the Hong Kong Representative of FTIF's website at http://www.franklintempleton.com.hk (The website has not been reviewed by the SFC.)

What does this mean to you?

If you wish to continue to invest in the Investment Choice after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice, you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.
