We are writing to let you know about the changes to the Underlying Fund. You have invested in the investment choice corresponding to the Underlying Fund, which are listed in the "Which investment choices are affected?" table below under the column "Name and code of the investment choice".

What is happening?

We have been notified by Capital International Management Company Sàrl that the Board of Directors of CIF has taken the following decision with regards to the Underlying Fund:

Integration of ESG binding criteria in the Underlying Fund, which currently qualifies as a financial product falling under Article 6 under the Sustainable Finance Disclosure Regulation ("SFDR"). This will result in the Underlying Fund becoming subject to the requirements of Article 8 under SFDR on December 1, 2023.

The Hong Kong Offering Documents has been updated to reflect that the Underlying Fund will integrate ESG features and will adopt additional binding ESG criteria to promote environmental and/or social characteristics. These updates will be effective on December 1, 2023 (the "Adoption Date").



With effect from the Adoption Date, the Underlying Fund will:

- adopt ESG and norms-based negative screening criteria; and
- be managed to a carbon target¹.

Saved as disclosed above, the Underlying Fund will keep the same investment objective investment strategy and investment team, and its risk profile will not be affected.

The costs and expenses related to the change of classification of the Underlying Fund under the SFDR from Article 6 to Article 8 will be borne by the Underlying Fund.

The changes above do not amount to material changes of the Underlying Fund. Capital International Management Company Sàrl does not expect that the changes will affect the risks applicable to the Underlying Fund and does not expect the changes to (i) result in any change in the operation and/or manner in which the Underlying Fund is being managed (ii) result in changes in the fee level/cost in managing the Underlying Fund and (iii) materially prejudice the existing investors' rights or interests.

What does this mean to you?

If you wish to continue to invest in the Investment Choice after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice, you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

Capital International Management Company Sàrl 已通知我們·CIF的董事會已就該相關基金作出以下決定:

於目前符合資格屬於《可持續金融資訊披露條例》(「SFDR」)第6條項下金融產品的該相關基金納入具約束力的ESG標準。此將導致該相關基金自2023年12月1日起須遵守SFDR第8條的規定。

香港發售文件已更新,以反映該相關基金將納入ESG特性,並將採納額外具約束力的ESG標準以推動環境及/或社會特徵。該等更新將於2023年12月1日(「採納日期」)生效。

自採納日期起,該相關基金將:

- 採納ESG和規範為本負面篩選標準;及
- 依據某碳目標管理1。

除上文所披露者外,該相關基金將維持相同投資目標、投資策略及投資團隊,而其風險概況將 不受影響。

與該相關基金於SFDR項下的分類從第6條更改為第8條相關的成本及開支將由該相關基金承擔。

上述變更不會對該相關基金構成重大變化。Capital International Management Company Sàrl 並不預期變更會影響適用於該相關基金的風險,而且並不預期變更會(i)導致該相關基金的營運及/或管理方式有任何轉變;(ii)導致管理該相關基金的費用水平/成本改變及(iii)對現有投資者的權利或利益構成重大損害。
