We are writing to let you know about the changes to the Underlying Fund. You have invested in the investment choice corresponding to the Underlying Fund, which are listed in the "Which investment choices are affected?" table below under the column "Name and code of the investment choice".

What is happening?

Corporate Director of Fidelity Funds has notified us that they have decided to change the name of the Underlying Fund. Fidelity Funds – Sustainable Euro Cash Fund, will be re-named Fidelity Funds – Euro Cash Fund.

The name change reflects the evolution of the application of regulation relating to the promotion of mutual funds and sustainable investments. For the avoidance of doubt, all other features of the Underlying Fund, and the manner in which the Underlying Fund is being managed in practice, remain unchanged. There will also be no change to the Chinese names of the Underlying Fund.

Any administrative expenses triggered by the change (including any legal, audit, mailing and regulatory charges) will be borne by FIL Fund Management Limited, the Investment Manager of Fidelity Funds (and/or any of its affiliates within the FIL Group).

The above change has taken effect on April 11, 2023 and will be reflected in the next update to the Hong Kong Offering Documents.



In view of the change to the English name of the Underlying Fund, the English name of the Investment Choice corresponding to the Underlying Fund has also been changed with effect from April 11, 2023 as below:
