We are writing to let you know about the change to the Underlying Fund. You have invested in the investment choice corresponding to the Underlying Fund, which are listed in the table below "Which investment choice is affected?" under the column "Name and code of the investment choice".

What is happening?

The Board of Directors of Pictet ("Board") has notified us of the following update to the Prospectus of Pictet which has taken effect on January 1, 2023 (the "Effective Date"), unless otherwise specified.

Re-classification of the Underlying Fund under the Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector ("SFDR")

Due to the evolving regulatory landscape in relation to the SFDR, the Board has decided to reclassify the SFDR category of the Underlying Fund from "Article 9" to "Article 8".

For the avoidance of doubt, there is no change to the investment objective or policy of the Underlying Fund as a result of the re-classification. In particular, the Underlying Fund will continue to apply a sustainable strategy which aims to achieve a positive environmental and/or social impact. There is also no change to the Underlying Fund's investment process integrating environmental, social and governance (ESG) factors as currently disclosed in the Hong Kong offering documents, and the portfolios of the Underlying Fund will remain unchanged and will continue to hold sustainable investments.



In addition, the Underlying Fund will continue to incorporate ESG factors as its key investment focus and reflect such in its investment policy. There is no change in the operation or manner in which the Underlying Fund is being managed.

In view of the above, the Board considers that:

- the re-classification does not amount to a material change to the Underlying Fund;
- there will be no material change or increase in the overall risk profile of the Underlying Fund following the reclassification: and
- the re-classification does not have a material adverse impact on investors' rights or interests (including changes that may limit investors' ability in exercising their rights).

Update to the Hong Kong offering documents

The Prospectus of Pictet will be updated to reflect the above re-classification in due course, and will be available on their website, www.assetmanagement.pictet¹.

What does this mean to you?

If you wish to continue to invest in the Investment Choice after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice, you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

百達的董事會(「**董事會**」)已通知我們對百達公開說明書的以下更新·除非另有訂明·否則有關更新已於**2023**年1月1日起生效(「**生效日期**」)。

根據2019年11月27日有關金融服務業的可持續發展相關披露之歐洲議會和理事會規例 (EU)2019/2088(「可持續發展金融披露規例」)重新分類該相關基金

由於有關可持續發展金融披露規例的監管環境不斷演變,董事會已決定將該相關基金的可持續發展金融披露規例類別由「第9條」重新分類為「第8條」。

為免引起疑問·該相關基金的投資目標或政策不會因重新分類而產生變更。具體而言·該相關基金將繼續採用可持續發展策略·有關策略旨在達到正面環境及/或社會影響。香港發售文件目前披露的該相關基金的投資程序納入環境、社會及管治(ESG)因素亦概無變更·而該相關基金的投資組合將維持不變並繼續持有可持續投資。

此外·該相關基金將繼續納入ESG因素作為其主要投資焦點·並於其投資政策中反映有關因素。該相關基金的營運或管理方式概無任何變更。

鑑於上述事官,董事會認為:

- 重新分類並不構成對該相關基金的重大變更;
- 重新分類後將不會對該相關基金的整體風險概況帶來重大變更或增加;及
- 重新分類不會對投資者的權利或權益造成重大不利影響(包括可能限制投資者行使其權利 之能力的變更)。
