Removal of benchmark for the Franklin Templeton Investment Funds - Templeton Global Climate Change Fund (the "Underlying Fund")

Dear valued customer,

We are writing to let you know about the changes to the Underlying Fund. You have invested in the investment choice corresponding to the Underlying Fund, which are listed in the "Which investment choice is affected?" table below under the column "Name and code of the investment choice".

#### What is happening?

We have been notified by Franklin Templeton Investments (Asia) Limited, as Hong Kong Representative of the FTIF, that the MSCI ACWI Climate Change Index (the "Benchmark") used to measure the sustainable investment objective of the Underlying Fund was removed with effect from January 1, 2023 as the Benchmark follows a different approach to decarbonization, which is one of the investment objectives of the Underlying Fund (i.e. to contribute towards climate change mitigation and adaptation as considered by the Paris Climate Agreement). The primary benchmark of the Underlying Fund, namely the MSCI All Country World Index used for performance comparison purposes, remains unchanged.

Other than the change as outlined above, all other features of the Underlying Fund remain the same and there will be no impact on the asset allocation or risk profile to the Underlying Fund. The change sets out in this letter will not give rise to any change in the fee level or fee structure of the FTIF and the Underlying Fund, nor any additional costs, expense, rights or interests to the Investors (other than the cost of publishing the post notification letter). Any additional costs and expenses arising from the change will be borne by the Management Company.



The Explanatory Memorandum of the FTIF (which is available for download from the Hong Kong Representative's website at www.franklintempleton.com.hk<sup>1</sup>) will be updated to reflect the above change in due course.

#### What does this mean to you?

If you wish to continue to invest in the Investment Choice after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice, you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

富蘭克林的香港代表富蘭克林鄧普頓投資(亞洲)有限公司已通知我們,由2023年1月1日起,用於衡量該相關基金可持續投資目標的摩根士丹利所有國家世界指數氣候變遷指數(MSCI ACWI Climate Change Index)(「基準」)被刪除,因爲基準遵循不同的減碳方法,減碳是該相關基金的投資目標之一(為《巴黎氣候協定》所考量的減緩及適應氣候變化做出貢獻)。該相關基金的主要基準,即用於比較表現目的之摩根士丹利所有國家世界指數(MSCI All Country World Index),保持不變。

除上述變更外,該相關基金的所有其他特徵保持不變,且不會對該相關基金的資產配置或風險概況產生影響。本函件所載之變更預計不會導致富蘭克林及該相關基金的收費水平或收費結構發生任何變化,亦不會為投資者帶來額外的成本、費用、權利或利益(發佈事後通知信函的費用除外)。因此變更而產生的任何額外成本及費用將由管理公司承擔。
