Note 注意

The documents must be valid (must be less than 12 months old at point of application) and the document must be either originals or certified as true copies by a suitable certifier.

For certified true copied documents, suitable certifiers will fall into the following categories:

如需通過核實的真實影印副本的文件,合適的核實人將分為以下幾類

- 1. A regulated introducer, based in a FATF country (recognized jurisdiction) 位於金融行動特別工作組的國家受監管的中介人(認可的司法管轄區)
- A notary public, lawyer or an embassy official (from the country who issued the document) 公證人、律師或大使館官員(來自簽發文件的國家)
- 3. An individual employed by an introducer who has been approved by Zurich to act as a suitable certifier 受僱於獲蘇黎世認可的中介人的僱員
- 4. An accountant who must be a member of an institute of professional organization 會計師為專業組織機構中的成員
- 5. An authorized employee of the Zurich group 獲蘇黎世集團授權的員工
