Changes to Janus Henderson Horizon Fund (“JHHF”)

Unless otherwise defined in this letter, all other capitalized terms used herein shall bear the same meaning as capitalized terms used in the prospectus of JHHF dated December 29, 2022 (the “Prospectus”), the Hong Kong Covering Document dated January 2023 (“HKCD”) and the latest relevant Product Key Fact Statement(s) (“KFS”) (collectively the “Hong Kong Offering Documents”).

Dear valued customer,

We are writing to let you know about the changes to JHHF and the Underlying Funds (as defined below). What is happening?

We have been notified by the chairman of JHHF of the following changes to JHHF, these changes have been reflected in the amended Hong Kong Offering Documents of JHHF with effect from December 29, 2022, unless otherwise specified.

1. EU Sustainable Finance Disclosure Regulation – further regulatory disclosure requirements for all article 8 and 9 SFDR Funds

In March 2021, the Regulation (EU) 2019/2088 of November 27, 2019 on sustainability-related disclosures in the financial services sector (“**SFDR**”) came into force, which stipulated that the Prospectus of JHHF must include prescript and standardized sustainability-related disclosures in order to provide further information for investors on how sustainability risks are considered in the investment decisions, and the likely impact on investment returns.

JHHF first introduced these disclosures into its Prospectus in 2021, however the SFDR disclosure requirements have evolved over time as the European Union (“**EU**”) continues to issue further guidance on their expectations in relation thereto.

In addition to SFDR, investors should note that there are also further disclosure requirements concerning the Regulation (EU) 2020/852 of June 18, 2020 on the establishment of a framework to facilitate sustainable investments amending Regulation (EU) 2019/2088 (the “**Taxonomy Regulation**”), which sets out an EU-wide framework (a classification system known as “taxonomy”) according to which investors and businesses can assess whether certain economic activities are sustainable from an environmental / climate perspective. The first set of disclosure requirements relating to the Taxonomy Regulation came into effect on January 1, 2022.

In response to the evolving SFDR and Taxonomy Regulation level 1 and level 2 disclosure requirements, they are now updating the existing disclosures in the Prospectus pursuant to the Commission Delegated Regulation (EU) 2022/1288 of April 6, 2022 (Regulatory Technical Standards (RTS) under the SFDR, the “**SFDR RTS**”).

In light of the above, the Prospectus of JHHF have been amended to further:

- remove the relevant parts under the Appendix 1 (“Sustainability Approach” of the Prospectus) which will be further described in the relevant SFDR RTS annexes;
- include under the Appendix 1 (“Sustainability Approach” of the Prospectus) the relevant annexes in compliance with the relevant templates pursuant to the SFDR RTS for each article 8 and 9 SFDR fund of JHHF by replacing the existing text under the same Appendix;
- move the section previously named “All Other Funds, within the meaning of Article 6 of SFDR” (describing, inter alia, the manner in which sustainability risks are integrated into the investment decisions of the Investment Manager, the likely impacts of sustainability risks on the returns of the Fund) to Section “General Risk Considerations Applicable to All Funds”.

Janus Henderson Horizon Fund - Asia-Pacific Property Income Fund, Janus Henderson Horizon Fund – Global Property Equities Fund and Janus Henderson Horizon Fund – Global Technology Leaders Fund are article 8 SFDR funds.

2. Other Merely Editorial Changes

The Hong Kong Offering Documents have also been updated to reflect other general miscellaneous, administrative and merely editorial and/or clarificatory updates.

Investors may obtain the revised Hong Kong Offering Documents, the Articles, as well as the annual and semi-annual reports of JHHF at www.janushenderson.com¹.

What does this mean to you?

If you wish to continue to invest in the Investment Choice(s) after considering the changes outlined above, you will not need to take any action. However, if you do not wish to maintain your investment in the Investment Choice(s), you may switch your existing holdings or redirect your future contribution allocations to alternative investment choice(s) by submitting an instruction to us, free of charge.

We recommend that you contact your licensed insurance intermediary in the first instance, who will be able to advise you of the alternative investment choice(s). For information on the fees and charges and the respective risk factors of our range of investment choices, please refer to the product brochure of the respective Schemes and the offering documents of the underlying funds made available by us upon request.

修訂事項

JHHF的主席已通知我們有以下對JHHF的變更，除非下文另有註明，該等變更已反映於JHHF的經修訂香港銷售文件，自2022年12月29日起生效。

1. 歐盟可持續金融披露規例—對所有第8條及第9條SFDR基金的進一步監管披露要求

2019年11月27日金融服務業有關可持續發展的披露之歐盟規例2019/2088號（「SFDR」）已於2021年3月生效，規定JHHF的招股章程必須載列規範化及標準化的可持續相關披露，以便為投資者提供有關在作出投資決策時如何考慮可持續風險，以及對投資回報可能產生的影響之進一步資料。

JHHF於2021年首次將該等披露納入其招股章程，然而，歐洲聯盟（「歐盟」）繼續就其對SFDR的相關期望發出進一步指引，因此SFDR披露要求已隨著時間演變。

除SFDR外，投資者應注意還有關於修訂歐盟規例2019/2088號之2020年6月18日就建立促進可持續投資框架之歐盟規例2020/852號（「分類規例」）之進一步披露要求，分類規例訂明一個涵蓋整個歐盟的框架（稱為「分類」的歸類系統），投資者及企業可根據該框架從環境／氣候角度評估若干經濟活動是否屬可持續發展。首套有關分類規例的披露要求已於2022年1月1日生效。

為回應不斷演變的SFDR及分類規例1級及2級披露要求，JHHF現正根據2022年4月6日的歐盟委員會授權規例2022/1288號（SFDR項下的監管技術標準（RTS），「SFDR RTS」）更新招股章程的現有披露。

鑑於上文所述，JHHF的招股章程已作出修訂，以進一步：

- 刪除附錄1（招股章程的「可持續方針」）下的相關部分，有關部分將在相關的SFDR RTS附件中進一步描述；
- 在附錄1（招股章程的「可持續方針」）項下就JHHF的每項第8條及9條基金納入符合根據SFDR RTS的相關範本之相關附件，以取代同一附錄下的現有文本；
- 把之前標題為「符合SFDR第6條定義的所有其他基金」一節（描述（其中包括）可持續風險被納入投資經理的投資決策之方式、可持續風險可能對基金回報產生的影響）移至「適用於所有基金的一般風險考慮」一節。

駿利亨德森遠見基金 - 亞太地產收益基金、駿利亨德森遠見基金 - 環球地產股票基金及駿利亨德森遠見基金 - 環球科技領先基金均為SFDR第8條基金。

2. 其他純粹編輯方面的變更

香港銷售文件亦已作出更新以反映其他一般雜項、行政及純粹編輯及／或澄清方面的更新。

投資者可從www.janushenderson.com¹取得經修訂的香港銷售文件、《組織章程細則》，以及年度及半年度報告。

對閣下產生的影響

如閣下在考慮上述變更後仍繼續投資於該等投資選擇，則無需就此修訂作出任何行動。倘若閣下不欲繼續投資於該等投資選擇，可向本公司遞交轉換現有投資或重新指定未來供款分配至其他投資選擇的指示，費用全免。

我們建議閣下首先諮詢閣下的持牌保險中介人，以取得其他投資選擇的建議。有關本公司投資選擇（包括費用及收費，以及其相關風險因素）的詳情，請參閱相關計劃的產品介紹冊及相關基金的銷售文件，本公司會應要求提供上述銷售文件。
