Why should you complete this form?

Automatic Exchange of Information (AEOI) is a standard through which tax authorities in different countries can routinely exchange information about financial accounts held by taxpayers. The standards include, but are not limited to, Foreign Account Tax Compliance Act (FATCA) and Common Reporting Standard (CRS). Financial institutions must identity and report any account holders who are taxpayers in other countries in accordance with the AEOI agreements.

Please note, further information regarding your tax obligations may be required before your transaction can be completed. This is to ensure that Zurich fulfils its reporting obligations to the UAE Tax Authorities. To reduce the likelihood of your transaction being delayed please ensure that you complete the tax information sections in full.
