Simple Wealth charges

Establishment charge

5% is charged on each premium received and deducted for the first three years from the date it is paid.

The charge is deducted monthly as shown below:

Year	Monthly charge
1	0.17%
2	0.17%
3	0.08%

Monthly policy charge

USD 15 monthly total premiums reach USD 60,000, then the charge stops. Other currencies are below.

Conditional charge

Surrender charge

This charge is deducted only if you fully surrender your policy during the first three years of paying a premium. The charge applies on each premium paid and the charge will depend on when the surrender takes place.
