(DEIB) Strategy Workshop (Half Day)

Sustainability

Our Sustainability Fund has now been fully allocated. A new application window will open in December 2024

It took less than seven months for the 2024 funds to fly out the door! With the monies exhausted, the **Sustainability fund 2024 has now closed.**

Many thanks to all our partners that made an application for funding. We're delighted to say that our success rate remains at 100% and we've been pleased to work with every partner that applied to us to secure the funds they needed.

If you'd like to find out more about who we've funded, you'll find details of the activities of all 21 partners supported since the fund was launched in May 2023, on the **ZCT HUB**.

The Sustainability Fund will have budget allocated from 01 January

2025. Therefore, in preparation, we will be opening the 2025 fund for applications on **01 December 2024**.

Given the size of the fund and the number of partners we support, please note that we're only able to accept applications from partners who have NOT applied to the fund before. The first tranche of funding decisions will take place by mid- January 2025.

The 2025 fund will remain open until all monies have been spent - so the quicker you get your application to us, the more likely it is that you'll be able to secure funding.
