- a) Beneficial Owner(s) in relation to a corporation, partnership and incorporated body or trust, means an individual who fulfils any of the following criteria:
- owns or controls, directly or indirectly, not less than 25% of the issued share capital of the corporation/ share of the capital or profits of the partnership/capital of the trust property; or
- is, directly or indirectly, entitled to exercise or control the exercise of no less than 25% of the voting rights at general meetings of the corporation/in the partnership; or
- · exercises ultimate control over the management of the corporation/partnership; or
- · settlor, protector or enforcer, in case of trust; or
- if the policyowner is acting on behalf of another person, means the other person.
- b) The documents must be valid (must be less than 12 months old at point of application) and the document must be either originals or certified as true copies by a suitable certifier.

For certified true copied documents, suitable certifiers will fall into the following categories.

- · A regulated introducer, based in a FATF country (recognized jurisdiction).
- A notary public, lawyer or an embassy official (from the country who issued the document).
- · An individual employed by an introducer who has been approved by Zurich to act as a suitable certifier.
- · An accountant who must be a member of an institute of professional organization.
- · An authorized employee of the Zurich group.

The phrase 'I certify that this is a true copy of the original' should be written on, or with, all certified documents. Please include all information below.
